Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

**Notes on Hierarchy of Controls:** Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Slips, trips and falls, manual handling injuries	3H	<ul style="list-style-type: none"> <li>- Proper housekeeping and site maintenance: Keep the work area clean, free from debris, clutter, and obstacles that can potentially lead to slips, trips, or falls.</li> <li>- Adequate signage and safety barriers: Install appropriate signs and barriers around the work areas to notify employees of potential hazards and prevent unauthorised access.</li> <li>- Provide training and instructions: Ensure all workers involved in laying stormwater are well trained and knowledgeable about proper techniques for manual handling to minimise the risk of injury.</li> <li>- Use appropriate PPE: Provide workers with suitable Personal Protective Equipment (PPE), such as slip-resistant footwear, gloves, and hard hats, to protect them from possible hazards.</li> <li>- Implement a buddy system: Encourage workers to engage in teamwork when lifting heavy objects to distribute the load evenly, reducing the risk of manual handling injuries.</li> <li>- Utilise mechanical aids: Wherever possible, use machinery, trolleys, or other tools to help move heavy objects and reduce the physical strain on workers.</li> <li>- Inspect equipment regularly: Frequently check the condition and functionality of any tools or equipment used during the stormwater laying process, replacing or servicing any worn-out or faulty items immediately.</li> <li>- Develop an emergency response plan: Establish procedures for responding promptly to incidents such as slips or falls, ensuring that all workers are familiar with these plans and know how to execute them when necessary.</li> <li>- Emphasise proper ergonomics: Instruct workers on best practices for maintaining correct body posture during manual handling tasks to lessen the chance of strain or injury.</li> <li>- Establish safe work zones: Clearly delineate specific working zones for different activities, minimising the possibility of collisions or accidental interference between workers carrying out various tasks.</li> <li>- Regularly review and update the SWMS: Continuously assess and monitor the efficacy of the control measures in place, making adjustments or improvements as needed to maintain optimal workers' health and safety standards.</li> </ul>	2M

## SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

**The SWMS must be reviewed regularly** to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

**The SWMS must be monitored regularly** for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
