Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.			
The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.



Suplement a tool management system where each tool has its designated storage spot when not in use. Regularly inspect tools for wear and tear, ensuring damaged tools are repaired or replaced promptly to prevent their incorrect usage. Display safety signage reminding workers of potential trip hazards and the necessity of vigilance around these risks. Assign a safety officer to monitor ongoing activities and ensure compliance with safety measures throughout the preparation phase. 	1L

Use mechanical aids such as trolleys, forklifts, or hoists to move heavy materials, minimising manual lifting wherever possible. Implement a team-lifting approach for heavy or awkward materials to distribute weight evenly and reduce individual strain. Clearly mark lifting zones and provide guidance on safe lifting procedures, including proper posture and technique. Conduct regular tool box talks focusing on safe material handling practices to reinforce safety protocols. SAFE WORK IN THE STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains a fective of must be reviewed (and revised if necessary) if relevant control measures are revised. The view process should be carried out in consultation with workers (including contractors of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU mast ensure that advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a rest of the review are advised of the changes in a way that will enable them to implement their duties and the involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:
