ALL PERSONNEL PARTICIPATING IN ANY ACTIVITY ON THIS SWMS MUST HAVE THE FOLLOWING COMMUNICATED

Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.



Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Slips, trips and falls, Incorrect manual handling techniques	2M	<ul style="list-style-type: none"> - Conduct a site assessment to identify any potential slip, trip, or fall hazards prior to commencing work. - Clearly mark and remove any obstacles or debris in the work area to maintain a clean and organised space. - Ensure all employees have appropriate non-slip footwear that is suitable for the work environment. - Utilise barriers, cones, or tape to indicate slippery or uneven surfaces and keep unauthorised personnel away. - Train workers on safe manual handling techniques, emphasizing the importance of lifting with their legs and maintaining a straight back. - Implement mechanical aids such as trolleys or hoists to assist with moving heavy or awkward objects where possible. - Schedule regular breaks for workers to avoid fatigue, which can increase the risk of slips, trips, and falls. - Ensure adequate lighting in the work area so that all surfaces and obstacles are clearly visible. - Encourage a culture of safety by having workers report hazards immediately and participate in regular safety meetings. - Provide training sessions focused on workplace ergonomics to help prevent injuries related to improper manual handling. 	1L

Site Set Up	Falling objects, Working in proximity to traffic or machinery	3H	<ul style="list-style-type: none"> - Conduct a site-specific risk assessment to identify potential hazards related to falling objects and proximity to traffic or machinery. - Erect secure barriers or fencing around the work area to prevent unauthorised access and to maintain a safe distance from traffic and operating machinery. - Implement clear signage to alert all workers and visitors about the presence of falling object risks and high-traffic areas. - Ensure that all tools, equipment, and materials are properly secured when not in use to minimise the risk of them falling. - Use toe boards and guardrails on elevated work platforms to prevent materials from being knocked off. - Provide and enforce the use of personal protective equipment (PPE) such as hard hats and high-visibility clothing for all workers on-site. - Establish exclusion zones where only authorised personnel are allowed, especially in areas where objects might fall or where machinery operates. - Schedule work such that activities involving lifting or moving overhead loads happen outside of peak site traffic times whenever possible. - Employ spotters or banksman to manage worker and vehicle movement around heavy machinery and ensure clear communication between operators and labourers. 	1L

Setting Out Area	Uneven surfaces, Over-exertion	2M	<ul style="list-style-type: none"> - Conduct a site assessment to identify any uneven surfaces and mark them clearly to alert workers. - Use appropriate personal protective equipment including sturdy footwear with good ankle support to prevent trips or falls. - Implement administrative controls by organising a designated walkway with warning signs to guide workers safely around the area. - Apply manual handling techniques training for all workers to reduce the risk of over-exertion during levelling activities. - Utilise mechanical aids such as trolleys or hoists to assist in moving heavy materials, minimising physical strain. - Ensure all tools and equipment used are well maintained and suitable for reducing physical effort required in the task. - Allocate regular breaks and rotate tasks among workers to avoid prolonged exertion in one activity. - Engage experienced personnel to operate machinery or perform tasks that require precision to avoid unnecessary physical efforts. - Limit work in adverse weather conditions that could exacerbate difficult surfaces and increase physical stress. - Use levelling instruments such as laser levels to ensure accuracy while reducing the need for excess physical reshaping of the ground. - Have a first aid kit readily accessible on-site and ensure there is at least one person trained in first aid to handle any incidents promptly. 	1L

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
