The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Institute orkers to bend their knees and keep their back straight while lifting to avoid injury. Plan the using route ahead of time to ensure it is the most efficient and least hazardous path. Italiate tasks among workers to prevent fatigue and reduce the risk of injury associated with repetitive lifting. Limit the weight of loads to a manageable size according to each worker's capability and established safety guidelines. Set up an area for staging and preparation where windows or doors can be securely held before lifting. Maintain open communication between team members during the lift to coordinate movements and respond quickly to any issues. 	2M

SAFE WORK IN THE STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains a fective of must be reviewed (and revised if necessary) if relevant control measures are revised. The view process should be carried out in consultation with workers (including contractors of the SWMS and their health and safety representatives who represented that work group at the workplace.
