Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Electrical hazards, Trip hazards	3H	<ul style="list-style-type: none"> - Conduct a thorough site inspection to identify and rectify any electrical hazards before beginning work. - Ensure all electrical equipment is properly tested and tagged according to safety regulations. - Use insulated tools and wear appropriate personal protective equipment such as rubber gloves and boots when dealing with electrical installations. - Clearly mark and barricade areas where trip hazards have been identified to prevent accidental falls. - Regularly inspect walkways and work areas for any obstructions or uneven surfaces, and ensure these are kept clear at all times. - Implement adequate lighting in work areas to enhance visibility and reduce the risk of tripping over unseen obstacles. - Keep all cables and wires organised and secured, using cable covers or conduits to prevent them from creating trip hazards. - Provide comprehensive training to employees on recognising potential trip hazards and emphasise the importance of maintaining a tidy workspace. - Develop and communicate an emergency response plan specifically addressing procedures related to electrical incidents and injuries from trips or falls. - Assign a dedicated safety officer to monitor adherence to safety protocols and promptly address any emerging hazards during the preparation phase. - Ensure all personnel involved in the load testing have completed relevant safety induction training and understand the specific risks associated with their tasks. - Regularly review and update safety measures in line with current best practices and legislative changes, ensuring continuous improvement in safety standards. 	1L

Pre-Testing	Falling objects, Noise Exposure	3H	<ul style="list-style-type: none"> - Conduct a site inspection to identify and secure any loose materials or tools that could potentially become falling objects during the test. - Install protective barriers or catch platforms below areas where falling objects may pose a risk to personnel or equipment. - Maintain a clear exclusion zone around the testing area to prevent unauthorised access and minimise exposure to potential hazards. - Ensure all workers wear appropriate personal protective equipment (PPE), including hard hats and hearing protection, suitable for the noise level. - Use signage to warn of overhead work and high noise levels, ensuring they are visible to all personnel in and around the area. - Limit the number of people present near the testing site to essential personnel only, reducing the risk of injury from falling objects or noise exposure. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
