Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Loading Dangerous Goods	Handling heavy items, Exposure to dangerous goods, Slips and falls	4A	<ul style="list-style-type: none"> - Conduct a pre-start safety briefing to ensure all workers are aware of the hazards associated with loading dangerous goods. - Implement a buddy system where employees work in pairs or groups to help spot hazards and assist in safe handling of heavy items. - Use appropriate personal protective equipment (PPE) such as gloves, long-sleeve shirts, safety goggles, and steel-toed boots to minimise exposure to dangerous goods and prevent injuries from slips and falls. - Ensure workers have been trained in manual handling techniques to reduce the risk of musculoskeletal injuries when lifting or moving heavy items. - Make use of mechanical aids and machinery like forklifts, hand trucks, and pallet jacks to minimise the need for manual handling of heavy items. - Clearly mark designated areas for loading and unloading, including pathways and zones where certain activities are restricted, to prevent unauthorised personnel from entering hazardous areas. - Install non-slip flooring or apply slip-resistant coatings in loading areas to reduce the risk of slips and falls, particularly during wet conditions. - Regularly inspect and maintain equipment such as cargo straps, load binders, and forklifts to ensure they are in good working order and do not pose an additional hazard. - Implement spill containment measures, such as spill kits or absorbent materials, readily accessible in case of accidental release of dangerous goods. - Establish and communicate emergency response procedures, ensuring all workers are familiar with actions to take in the event of an incident involving dangerous goods. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review process should be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
