Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

			<ul style="list-style-type: none"> - Train personnel in safe vehicle operation practices and procedures specific to loading and unloading livestock. - Designate a spotter or guide to assist the driver when approaching and parking the vehicle to avoid blind spots and ensure precision. - Ensure the ground surface is stable and free from obstructions or hazards that could cause slips, trips, or falls. - Keep communication equipment readily available for coordinating movements between drivers and on-ground personnel. - Inspect livestock containment gates and fencing to ensure they are secure and capable of handling potential impacts from livestock. - Utilise wheel chocks on stationary vehicles to prevent any unintended movements during the loading or unloading process. - Appropriately use convex mirrors and rearview cameras where possible to increase visibility around livestock handling areas. - Establish an emergency protocol for dealing with unsecured livestock, including escape routes and personnel responsibilities. - Conduct regular safety briefings to ensure all personnel are aware of the procedures, roles, and hazards related to the loading/unloading process. 	
3. Opening/Closing Gates	Animal bites, Crush injuries from gates	3H	<ul style="list-style-type: none"> - Ensure all workers are trained in safe animal handling techniques to minimise the risk of bites and crush injuries. - Use personal protective equipment, such as gloves and steel-capped boots, to protect against bites and potential foot injuries. - Install anti-slip surfaces near gates to prevent slips and falls while opening or closing them. - Position yourself so that there is a solid barrier between yourself and the livestock whenever possible. - Identify and use escape routes in case of emergencies caused by aggressive animals or malfunctioning gates. - Maintain clear communication with team members via hand signals or radios to coordinate gate operations safely. - Regularly inspect and maintain gates and latches for defects to ensure they function correctly and do not accidentally swing open or closed. - Utilise quick-release mechanisms on gates where appropriate to allow for fast re-routing if an animal becomes aggressive. - Adopt a buddy system during loading and unloading to provide assistance and ensure another person can call for help if required. - Keep calm and avoid sudden movements which may spook the livestock and increase the likelihood of aggressive behaviour. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
