### ALL PERSONNEL PARTICIPATING IN ANY ACTIVITY ON THIS SWMS MUST HAVE THE FOLLOWING COMMUNICATED

Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

**Notes on Hierarchy of Controls:** Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

			<ul style="list-style-type: none"> <li>- All loading equipment such as forklifts, cranes, pulleys, etc., should be operated according to the manufacturers' instructions.</li> <li>- Install weight monitoring devices or scales to help ensure weight loads are not miscalculated. These will need to be calibrated regularly to maintain their accuracy.</li> <li>- Do not exceed the rated capacity of any lifting or hoisting equipment. Strictly enforce this rule among workers.</li> <li>- Use personal protective equipment (PPE) such as hard hats, steel-toed boots, gloves, visibility vests and safety glasses during the loading and unloading process.</li> <li>- Keep the loading area clean, clear and free of obstacles to prevent slips, trips or falls during the loading/unloading process.</li> <li>- Securely stack material loads and use straps and netting to prevent them from shifting during transport.</li> <li>- Encourage open communication among team members and foster a culture of safety where it's okay to speak up about potential hazards or unsafe practices.</li> </ul>

Loading Materials	Crushing injuries due to falling objects Strains from improper lifting methods	4A	<ul style="list-style-type: none"> <li>- Ensure all workers have received appropriate materials handling training, including proper lifting techniques, to minimise the risk of strains.</li> <li>- Utilise mechanical aids such as forklifts or hoists where possible to reduce the need for manual lifting of heavy objects.</li> <li>- All workers should wear appropriate personal protective equipment (PPE) such as safety boots and high visibility clothing to protect against crushing injuries.</li> <li>- Routinely inspect all lifting equipment before use to assure safe operation and address any potential issues that could increase hazards.</li> <li>- Make certain that the loading area is clear of unnecessary personnel to lessen likelihood of accidents.</li> <li>- Enforce strict adherence to cargo weight limit guidelines to avoid overloading which can lead to falling or collapsed materials.</li> <li>- Confirm that all items are securely stowed and sandwiched before moving to avoid shifting or slipping during transit.</li> <li>- Implement a consistent process for verifying that loads are evenly distributed and correctly secured.</li> <li>- Prevent working under suspended loads to avoid risks of being struck by unintentionally dropped materials.</li> <li>- Develop an emergency plan should accidental uncontrolled release of materials occur to ensure immediate response.</li> <li>- Regularly conduct safety briefings and reminder sessions with staff highlighting the importance of following safety measures when handling and transporting materials.</li> </ul>	2M

## SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

**The SWMS must be reviewed regularly** to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

**The SWMS must be monitored regularly** for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
