### ALL PERSONNEL PARTICIPATING IN ANY ACTIVITY ON THIS SWMS MUST HAVE THE FOLLOWING COMMUNICATED

Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

**Notes on Hierarchy of Controls:** Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Incorrect PPE, Inadequate training	2M	<ul style="list-style-type: none"> <li>- Conduct thorough risk assessments and safety inductions for all workers involved in the project, ensuring they understand the specific hazards associated with locating and exposing existing services.</li> <li>- Enforce the mandatory use of appropriate Personal Protective Equipment (PPE), such as high-visibility clothing, steel-toecapped boots, gloves, hard hats and safety glasses, for all personnel on site.</li> <li>- Establish a clear list of required PPE based on the specific job tasks, and display the list conspicuously at the worksite for easy reference by all workers.</li> <li>- Verify that all employees have completed relevant industry-specific training and hold valid certifications in areas such as utility detection, confined space entry, first aid, and traffic control, if required.</li> <li>- Provide regular refresher training courses for workers to enhance their skills, deepen hazard awareness, and ensure compliance with current Workplace Health and Safety standards.</li> <li>- Develop comprehensive Safe Work Method Statements (SWMS) outlining the procedures for locating and exposing existing utilities, including detailed information about the potential hazards, control measures, and emergency protocols.</li> <li>- Implement a strict incident-reporting protocol that encourages workers to report any identified hazards or non-compliance issues so that corrective actions can be taken promptly.</li> <li>- Assign a competent supervisor to monitor every task closely, ensuring that all workers comply with the proper use of PPE and adherence to safe work procedures in performing the task.</li> <li>- Utilise signage to identify hazardous zones where locate and expose work is being performed, alerting pedestrians and other workers to maintain a safe distance from these areas.</li> <li>- Plan and coordinate work scheduling effectively to avoid overcrowding and minimise exposure to hazards within the designated workplaces.</li> <li>- Conduct regular equipment inspections, maintenance and audits to ensure all tools and devices needed for the locate and expose work are functioning correctly, thus minimising the risk of accidents due to equipment failure.</li> <li>- Foster a positive and supportive safety culture within the organisation by recognising and rewarding workers for adhering to safety protocols, encouraging open communication about safety concerns, and continuously reviewing and improving safety measures.</li> </ul>	1L

			<ul style="list-style-type: none"> <li>- Pre-mark work areas with coloured spray paint or marking flags to help visualise locations of services and potential hazard zones.</li> <li>- Conduct regular toolbox talks to inform workers about potential hazards and risk control measures for the task at hand.</li> <li>- Implement clear signage around the work area, particularly near trip hazards and busy areas, to alert workers.</li> <li>- Keep the worksite free from clutter and unnecessary materials to minimise potential tripping hazards.</li> <li>- Perform regular inspections of the worksite, updating markings as needed when uncovering new or missed services during the progress of works.</li> <li>- Use barricades, cones or cordons off the work area to prevent unauthorised persons from accessing potentially dangerous zones.</li> <li>- Ensure workers wear appropriate Personal Protective Equipment (PPE) like safety boots with non-slip soles, high visibility clothing and head protection to minimise potential injuries caused by those hazards.</li> <li>- Train employees in situational awareness to be vigilant of their surroundings and continuously assess potential risks while working on-site.</li> <li>- Set up safe walkways, paths and routes for workers to navigate through the worksite without facing trip hazards or encountering inaccurate site markings.</li> </ul>

## SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

**The SWMS must be reviewed regularly** to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

**The SWMS must be monitored regularly** for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
