Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

PPE (Personal Protective Equipment) is the least effective method.

Preparation	Insufficient personal protective equipment (PPE), lack of tools	2M	<ul style="list-style-type: none"> - Provide and ensure the use of appropriate personal protective equipment (PPE) such as gloves, safety glasses, and protective clothing. - Conduct a pre-start check to assess the condition of tools and make sure they are suitable for the task. - Inspect all equipment and tools for defects or damage before use, and replace any that are not in good condition. - Establish a clear workspace to avoid tripping hazards and ensure there is enough space for safe manoeuvring. - Ensure adequate lighting in the work area to clearly see all tasks being performed. - Train workers on the correct use and limitations of PPE and tools specific to loosening rusted nuts and bolts. - Use controlled torqueing tools designed to minimise the force needed to loosen tight fasteners without compromising safety. - Implement a system for reporting faults or shortages of PPE and tools immediately to supervisors or managers. - Display hazard signage to alert workers and passersby of potential risks when lightening rusted nuts and bolts. - Identify and label areas where emergency stops are located on electrical tools and equipment. - Allocate enough time for each task to prevent workers from rushing, which may lead to skipped safety steps or improper techniques. - Limit access to the work area to authorised personnel only to reduce unnecessary distractions and interference. - Provide refresher training sessions regularly to maintain awareness of workplace safety protocols related to this specific task. 	1L

The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
