Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Preparation	Manual handling injuries, Slips, trips and falls	3H	<ul style="list-style-type: none"> - Ensure all personnel are trained in proper manual handling techniques to minimise the risk of injuries. - Use mechanical aids such as trolleys or hoists when moving heavy or awkward items to reduce manual handling risks. - Conduct a pre-task assessment to identify potential slip, trip and fall hazards in the work area before starting the task. - Clear the work area of unnecessary equipment & debris to prevent trips and falls. - Maintain a clean and dry floor surface by cleaning up any spills immediately and marking wet areas with warning signs. - Wear appropriate non-slip footwear to enhance stability and reduce the likelihood of slips. - Arrange tools and materials in easy-to-reach positions to avoid overreaching and awkward postures. - Utilise a buddy system or team lifts for heavier loads to distribute weight and reduce strain on individual workers. - Mark uneven surfaces and elevation changes with bright tape or signage to alert workers and prevent trips. - Ensure adequate lighting in the work area to improve visibility and help identify potential hazards. 	2M

Inspection	Falling from height, exposure to noise	3H	<ul style="list-style-type: none"> - Ensure all personnel involved in the inspection are trained in working at heights procedures. - Use appropriate fall protection equipment such as harnesses and lanyards when working above ground level. - Conduct a pre-operation inspection of fall protection gear to ensure it is in good condition and properly fitted. - Install temporary guardrails or barriers around exposed edges where possible. - Implement a "buddy system" where workers are paired to monitor each other's safety while working at height. - Minimise the time spent working in elevated positions by planning the inspection thoroughly and efficiently. - Limit access to the work area to authorised personnel only to prevent accidental falls. - Schedule inspections during daylight hours whenever possible to benefit from natural light, reducing reliance on artificial lighting which may cast shadows. - Use hearing protection solutions appropriate for the noise level encountered during the inspection process. - Train workers on the hazards of noise exposure and proper use of hearing protection equipment. - Position generators or other noisy equipment away from work areas to minimise noise exposure. 	1L

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
