Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

This includes checking for wear and tear, potential damage, and ensuring all components are in working order. - Clear worksite: Ensure the area around the excavator is clear of debris, obstacles, and tripping hazards before beginning work to reduce the risk of accidents. - Provide adequate training: Ensure all personnel operating or working near excavators have received proper training in equipment operation, safety protocols, and PPE usage. - Develop site-specific risk assessments: Assess each worksite individually to identify any unique hazards or risks and implement effective control measures accordingly. - Utilise appropriate PPE: Workers must wear suitable personal protective equipment such as gloves, hard hats, safety glasses, hearing protection, and high-visibility clothing during the maintenance process. - Follow manufacturer guidelines: Always follow the manufacturer's instructions and guidelines for maintaining and operating excavator buckets to ensure safe and effective use. - Implement a lockout/tagout procedure: Before working on the excavator bucket, ensure it is locked out and tagged to prevent accidental activation of the equipment during maintenance. - Use lifting devices: If heavy components need to be lifted or moved during maintenance, utilise suitable lifting devices and follow safe lifting practices to minimise manual handling risks. - Maintain communication: Always communicate with team members when undertaking maintenance activities, particularly in areas with limited visibility or accessibility, to prevent accidental injury. - Implement an incident reporting system: Encourage workers to report any near misses, accidents, or hazards in the workplace so that appropriate corrective actions can be taken promptly. - Store tools and equipment properly: Keep all tools and equipment neatly organised and stored when not in use to minimise tripping hazards and other risks associated with poorly maintained equipment. - Schedule regular toolbox talks: Hold frequent toolbox talks to discuss safety topics and reinforce the importance of proper PPE and equipment maintenance. - Don't rush: Workers should never feel pressured to complete tasks quickly at the expense of safety. Encourage employees to work steadily and cautiously, paying close attention to their surroundings and any potential hazards during the preparation and maintenance process. 	1L

			<ul style="list-style-type: none"> - Encourage employees to report any concerns or issues related to equipment condition and functionality promptly. - Conduct visual inspections for visible defects such as cracked welds, damaged or worn components, excessive rust, and wear on wear surfaces and cutting edges. - Inspect attachment points, hydraulic connections, and locking mechanisms for proper functioning and security. - Check for proper condition, tension and alignment of belts, hoses, and fluids. - Verify the availability and accessibility of necessary tools, equipment, and personal protective equipment (PPE) before commencing equipment inspection and maintenance tasks. - Regularly review and update pre-start inspection and maintenance protocols to ensure adherence to Australian standards, regulations, and best practices. - Schedule periodic quality audits by an independent third-party to ensure work processes and procedures comply with current Australian WHS requirements. - Implement a preventative maintenance programme to address wear and tear and to prevent long-term defects. - Ensure the workspace is adequately lit and suitable for carrying out inspections and maintenance activities efficiently and safely. - Keep detailed records of all pre-start inspections, including equipment condition report, any identified defects and maintenance actions undertaken, and escalation procedures followed when necessary.

Loading excavator	Struck by objects, Overloading	3H	<ul style="list-style-type: none"> - Ensure that all workers involved in loading the excavator are provided with proper training and competency assessments to safely operate equipment and handle loads. - Conduct a pre-operational safety check before initiating any loading tasks, including a visual inspection of the working area, equipment, and materials. - Establish clear communication channels between the loaders, operators, and supervising personnel, and employ appropriate hand signals or wireless communication devices to coordinate tasks efficiently. - Utilise lifting accessories and devices that are suited for the specific excavator bucket size, weight and centre of gravity, ensuring they comply with Australian safety standards. - Regularly inspect and maintain lifting accessories, slings, chains, shackles, and hooks, replacing them when signs of wear or damage are detected. - Always confirm the accurate weight of the materials being loaded to prevent overloading the excavator bucket, which may lead to structural failure or tipping hazards. - Follow the manufacturer's recommendations on load limits and capacities for every excavator model, never exceeding these predefined guidelines. - Keep the surrounding work areas clean and free from obstructions to minimise the risk of workers being struck by objects during the loading process. - Whenever possible, designate exclusion zones around the loading area to restrict access to only essential personnel, thereby reducing the number of people susceptible to potential hazards. 	1L

			<ul style="list-style-type: none"> - Maintain a safe distance from the edge of the excavation site while operating the excavator, continually assessing ground stability and conditions. - Implement a suitable Traffic Management Plan to regulate the movement of vehicles and pedestrians in proximity to the loading zone, thereby preventing accidents and collisions. - Instruct workers to avoid standing beneath suspended loads originating from the excavator bucket, mitigating the risk of injuries resulting from falling materials or equipment. - Employ the use of Personal Protective Equipment (PPE) such as hard hats, high-visibility clothing, steel-toed boots and gloves as a supplementary protective measure against potential hazards. - Foster a culture of safety and open communication at the workplace, whereby workers are encouraged to report hazards or unsafe practices immediately, allowing for swift corrective action and continuous improvement in health and safety protocols.

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
