Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Inadequate training, Manual handling injuries	3H	<ul style="list-style-type: none"> - Conduct comprehensive training sessions for all workers involved in handling steel trusses to ensure they understand safe handling techniques and hazards. - Develop and distribute a detailed manual handling policy outlining best practices, including the use of proper lifting techniques. - Implement a buddy system where experienced workers mentor less experienced staff during the preparation phase. - Ensure that all personnel are provided with personal protective equipment (PPE) such as gloves, steel-toed boots, and hard hats. - Position mechanical aids like trolleys or forklifts strategically to assist in moving heavy trusses and reduce manual handling. - Schedule regular refresher courses to keep all workers updated on the latest safety procedures relevant to the handling of steel materials. - Set up signage and warning indicators around the work area to alert workers to potential hazards associated with truss handling. - Establish specific rest break schedules to prevent fatigue, especially during demanding manual tasks. - Conduct risk assessments before commencing any tasks involving the handling of trusses to identify potential hazards. - Encourage a culture of open communication where workers can report safety concerns or suggest improvements without fear of reprisal. - Designate a safety officer for each shift who will oversee compliance with manual handling procedures and offer immediate guidance as needed. - Regularly review and refine current handling procedures based on incident reports and feedback from on-site staff to enhance overall safety. 	2M

Pre-assembly Inspection	Cuts and abrasions, Eye injuries from dust particles	2L	<ul style="list-style-type: none"> - Conduct a pre-task briefing with all personnel to highlight potential hazards and reinforce safe work practices. - Ensure all workers involved in the task are wearing appropriate personal protective equipment (PPE), such as safety gloves, long-sleeved shirts, and eye protection like safety glasses or goggles. - Inspect tools and equipment prior to use to ensure they are in good working condition and suitable for the task at hand. - Maintaining a clean and organised workspace to reduce the risk of tripping hazards and facilitate a safer inspection process. - Use appropriate lighting in the work area to enhance visibility and reduce the risk of mishandling or missing potential defects. - Implement a buddy system where team members work in pairs to monitor each other's safety practices during the inspection. - Utilise materials handling equipment such as trolleys or cranes when manoeuvring heavy items to minimise manual handling risks. - Keep first aid supplies accessible and ensure at least one team member on site is trained in administering first aid. - Maintain clear communication among all workers through hand signals or radios, especially in noisy environments, to prevent accidents. - Identify and clearly mark unsafe areas or structures using barriers or signage to keep unqualified individuals away from potential hazards. 	1L

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
