If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Label and indicate areas where hazardous substances such as specific adhesives are stored or used, emphasising the importance of ventilation. Store tiles and materials at waist height if possible to avoid unnecessary bending or stretching during retrieval. Have first aid equipment readily available and ensure all workers are familiar with the emergency procedures related to accidents or exposure to hazardous substances. 	2M
