### ALL PERSONNEL PARTICIPATING IN ANY ACTIVITY ON THIS SWMS MUST HAVE THE FOLLOWING COMMUNICATED

Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

**Notes on Hierarchy of Controls:** Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Slips, trips or falls from debris, Electrical hazards	2M	<ul style="list-style-type: none"> <li>- Ensure all workers are trained and competent to operate the metal bending machine.</li> <li>- All pathways to, from, and around the machine should be kept clean and free from debris to prevent slips, trips or falls.</li> <li>- Have a qualified electrician regularly inspect the wiring of the machine for any faults or damages.</li> <li>- Make sure the metal bending machine is properly grounded to avoid electrical hazards.</li> <li>- Implement regular checks and maintenance on the machine to ensure it's functioning correctly and safely.</li> <li>- Proper work area lighting should be in place to enhance visibility reducing risks associated with operating machinery.</li> <li>- Protective wear like gloves, goggles, steel-capped boots and helmets should be mandatory during operation.</li> <li>- Establish safe boundaries or zones around the machine to keep non-operating staff at a safe distance.</li> <li>- Only allow authorised personnel within the specified safe working zone.</li> <li>- Always keep the machine turned off when not in use to avoid unintended operations leading to accidents.</li> <li>- Appropriate risk signage should be visible and clear surrounding machinery.</li> <li>- Regularly review and adjust safety measures as per legislations and industry best practices.</li> <li>- Immediate reporting and recording of hazards and near misses to management should be encouraged for prompt remedial action.</li> <li>- Emergency procedures including first aid or rescue plans should be well-planned and communicated to everyone involved.</li> </ul>	1L
2. Machine inspection	Mechanical malfunction, Electrical shocks	3H	<ul style="list-style-type: none"> <li>- Conduct a thorough and routine machine inspection before operation. Look for any visible signs of wear or breakage.</li> <li>- Ensure all machine guards and safety devices are in place and fully functional.</li> <li>- Use only approved and properly functioning equipment, promptly reporting any defects or malfunctions to management.</li> <li>- All employees should be trained in the correct operating procedures of the Metal Bending Machine including emergency shutdown.</li> <li>- Since metal bending machines require electricity to operate, ensure that all wirings and connections are correctly installed and in good condition.</li> <li>- Placement of clear markings at high risk electrical areas along with the use of protective gear such as rubber gloves and boots during handling can deter the chances of electrical shocks.</li> </ul>	1L

			<ul style="list-style-type: none"> <li>- Regularly inspect and test gadget switches and buttons to confirm they're working properly thus avoiding lasting contact with power-induced parts leading to electric shocks.</li> <li>- In case of a suspected malfunction, turn off and disconnect the machine until the issue is resolved.</li> <li>- Have first aid measures prepared nearby where an instant relief could be offered in MINOR situations of casualties caused by electric shocks or machine mishandlings.</li> <li>- Compliance checks should be conducted periodically to capture non-compliance users as part of an effort to enforce strict adherence to laid down precautionary measures.</li> </ul>	
3. Loading raw materials	Manual lifting injuries, Cuts from handling material	3H	<ul style="list-style-type: none"> <li>- Ensure proper manual handling procedures are in place. Train workers on safe lifting techniques to minimise the risk of sprains, strains and other musculoskeletal injuries.</li> <li>- Always wear appropriate personal protective equipment (PPE): This includes safety gloves to prevent cuts from handling materials, as well as hard hats and high visibility clothing that can help prevent accidents.</li> <li>- Use mechanical aids where necessary: Trolleys, forklifts or other mechanical-moving devices should be used for heavy loads to reduce chances of manual-handling-related injuries.</li> <li>- Regularly inspect handling equipment: Regular maintenance checks on such equipment can ensure they're functioning properly and present no additional risks.</li> <li>- Maintaining clean and tidy workspace: Decluttering work surfaces can minimise the likelihood of accidental slips, trips and falls.</li> <li>- Provide clear instructions on loading procedure: All steps involved in the process should be well-documented and accessible to all employees involved in the task.</li> <li>- Install safety guards on sharp edges: This can prevent cuts and lacerations from handling materials.</li> <li>- Continual supervision during loading: Regular monitoring can allow potential problems to be spotted and resolved before an accident occurs.</li> <li>- Organise regular health and safety trainings: Refresh workers' knowledge on workplace health and safety standards and practices frequently.</li> <li>- Instigate incident reporting: Workers should know how and why to report health and safety incidents. Understanding the consequences of unsafe practices reinforces importance of rules.</li> <li>- Regularly review and update Safe Work Method Statements (SWMS): Changes in personnel, equipment or processes may necessitate changes in your SWMS, so they should be undergoing regular review.</li> <li>- Encourage worker input on safety issues: Those doing the job often have valuable insights into possible hazards and can suggest practical solutions.</li> </ul>	2M

## SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

**The SWMS must be reviewed regularly** to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

**The SWMS must be monitored regularly** for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
