Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Preparation	Incorrect equipment selection, improper training	3H	<ul style="list-style-type: none"> - Adequate Equipment Selection: Ensure that the equipment selected for the task is optimal in terms of performance and safety. Always refer to manufacturer's recommendations and guidelines. - Comprehensive Training: Implement a training program to educate workers on the correct method of operating the Brazing Machine. This should include procedural protocols, emergency procedures and maintenance. - Regular Inspections: Monitor equipment daily before use to ensure it is in optimal working condition. A checklist should be used to standardise this process. - Install Safety Signage: Clear signage indicating controls for using the machine, as well as potential hazards, should be installed to maintain awareness among employees. - Personal Protective Equipment (PPE): Mandatory wearing of appropriate PPE such as gloves, safety glasses and protective clothing that are heat resistant and designed for metal work. - Secure Work Area: Ensure the workstation is organised and free of unnecessary items which could cause slip, trip or fall accidents. All pathways should be kept clear. - Well-ventilated Workspace: Ensure there is sufficient ventilation to avoid accumulation of harmful fumes emitted during the brazing operation. - Breaks to Prevent Fatigue: Encourage regular breaks amongst staff to minimise risks associated with fatigue. Exhaustion can lead to errors and accidents due to reduced concentration. - Pre-operation Checks: The operator must conduct pre-operation checks to identify any defects or abnormalities before starting operation. - Emergency Procedures: Establish and rehearse emergency procedures so that workers know exact steps to take in case of malfunctions or other urgent situations. This includes availability of first aid kits and trained first responders. 	2M

Make sure all operators have received proper training before they begin using it. - Equipment Testing: Perform regular testing to confirm if the machinery is operating properly. Any irregularities should be reported immediately. - Cooling systems: Use appropriate cooling systems to prevent overheating when machines are in continuous use. - Personal Protective Equipment (PPE): Workers should be supplied with and encouraged to use suitable PPE such as protective gloves, safety glasses or noise-reducing earmuffs. - Clear Operating Instructions: Display clear and concise operating instructions that detail what action to take in case of an emergency. - Proper Ventilation: Ensure that the work area has adequate and effective ventilation to avoid any harmful fumes from becoming concentrated. - Use manufacturer-approved parts: When repairs are necessary, only use parts that the manufacturer approves of to prevent failure of equipment. - Monitoring Workspace Temperature: Frequently monitor the temperature of the workspace around the machine to prevent overheating which may occur due to external factors in addition to the machine's operation. 	1L

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
