Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

**Notes on Hierarchy of Controls:** Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Improper training, inadequate protective equipment	3H	<ul style="list-style-type: none"> <li>- Implement Comprehensive Training: Ensure all workers operating the CNC milling machine are fully trained and equipped with skills required to handle the machine. A professional should conduct both practical and theoretical training sessions.</li> <li>- Personal Protective Equipment (PPE): Mandate use of appropriate PPE such as safety glasses, gloves, earplugs, and high-visibility vests. Workers should be educated about the importance of using these during operation.</li> <li>- Machine Inspection: Regular check-ups and timely maintenance of the milling machine can play a vital role in danger prevention. Always ensure that the machine is in perfect condition before starting any operations.</li> <li>- Comprehensive Risk Assessment: Carry out comprehensive risk assessment frequently to identify potential hazards. This helps formulate preventive measures before problems arise.</li> <li>- Safety Briefings: Begin each shift or workday with thorough safety briefings emphasising the risks associated with the task and highlighting the safety measures in place.</li> <li>- Emergency Procedures: Have established and well-practiced emergency procedures in case things go wrong. This includes knowledge of where first aid kits, emergency exits and equipment shut-off switches are.</li> <li>- Install Adequate Lighting: Proper lighting around the working area is essential for visibility to prevent mishaps related to lack of clarity while handling the machinery.</li> <li>- Clean and Organised Work Area: Keep work areas clean and clutter-free to avoid trip hazards and make it easier to reach emergency shut-off switches.</li> <li>- Strictly Follow Manufacturer's Guidelines: The manufacturer's guidelines give detailed information on the safe handling of the machine. Adhering to this information will significantly reduce risk exposure.</li> <li>- Use of Guards: Using machine guards help contain chips, coolant and prevent the operator from making direct contact with moving parts. They are installed over the point of operation, power transmission apparatus or other hazardous areas.</li> </ul>	2M

## SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

**The SWMS must be reviewed regularly** to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

**The SWMS must be monitored regularly** for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
