Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

This should encompass all aspects of use including start up, shut down, and emergency protocols. - Implement an ongoing review and refresher training system to ensure skills and knowledge are kept up-to-date. - Encourage proper ergonomics during operation to minimize physical strains. - Mandate the use of appropriate well-maintained Personal Protective Equipment (PPE) like safety goggles, gloves, earplugs, earmuffs, and steel-toed boots. - Promote regular breaks for handlers to prevent fatigue, which can lead to carelessness or mishaps. - Ensure working environment is well-lit and clear of unnecessary items that could cause trips or falls. - Establish a system for regular, thorough inspections for early detection of equipment malfunction or degradation. - Maintain an emergency stop mechanism within easy reach of the operator at all times. - Post proper safety signage to remind operators of protocol and risks. - Monitor workers' health and workplace factors routinely. If there's evidence suggesting that exposure to noise or vibration is inducing health problems, take immediate action to mitigate such risks. - Forbid usage if PPE, restraining devices or guarding is not in its designated place, improperly used or maintained. - Integrate frequent communication between workers and supervisors about safety issues and improvements. Workers should feel comfortable discussing concerns without fear of punishment. - Develop and revise safety procedures over time. It's important to constantly evaluate and improve safety measures based on observations, incidents, and advancements in technology. 	2M
2. Equipment Inspection	Faulty equipment, Unskilled operation	3H	<ul style="list-style-type: none"> - Regular Inspection: Enforce a routine maintenance schedule for the machinery to catch any potential faults before they can cause accidents. - Check Machine Operational Manual: The manual often provides detailed insights into safe handling, usage and potential threat areas within the machine. - Equip Appropriate Personal Protective Equipment (PPE): Ensure that all personnel have access to, and are wearing, suitable PPE. This could include gloves, safety glasses, ear muffs and possibly even heat-resistant attire depending on the specifics of the work process. - Operator Training: Implement an extensive training programme that equips all operatives with necessary skills and knowledge to use the machine effectively without endangering anyone's health or safety. - Safety Briefings: Hold regular, mandatory safety briefings to continually reinforce best practices and adherence to safety protocols. 	2M

			<ul style="list-style-type: none"> - Standard Operating Procedures: Develop, implement, and enforce standard operating procedures (SOPs) for operation of the shearing machine. - Clear Signage: Having clear visual representation reminding operators of potential risks and safety measures can go a long way in maintaining a safe environment. - Emergency Shut-off Procedures: Create and train all appropriate personnel on emergency shut-off procedures specific to the machinery. - Use of Guards and Barriers: Make sure guards and barriers are properly installed and not tampered with to prevent accidental contact with moving parts of the equipment. - Do Not Override Safety Systems: Never allow operators to override or disable any safety systems or devices installed on the machine. - Regular Breaks: Enforcing regular breaks can help to keep staff alert and aware, reducing the likelihood of mishaps due to fatigue or lack of focus. - Zero Tolerance Policy: Have a zero tolerance policy towards alcohol and drugs on site as these can impair control, coordination and judgement. - Incident Reporting: Encourage reporting of minor incidents or near misses, so potential hazards can be identified and rectified before they cause a serious accident.

Machine Set-Up	Improper alignment, Potential electrical hazards	3H	<ul style="list-style-type: none"> - Conduct regular inspections of the machine to ensure proper alignment and identify any issues promptly. - Use professional tools for machine set-up purposes to minimise the risk of improper alignment. - Every worker should undergo thorough training on how to operate and set up the Metal Shearing Machine safely. - Display clear instructions near the machine about the proper use and configurations, including maintaining safe distances from the cutting area. - Ensure all electrical equipment associated with the machine is tested and tagged as per Australian Standards. - Regularly maintain and service the shearing machine to prevent any possible mechanical failure leading to electrical hazards. - Avoid overloading circuits by limiting the number of devices connected to a single outlet. - Ensure there is an accessible and clearly marked emergency stop button in case of emergencies. - Install adequate lighting around the machine to ensure visibility during operations. - Always wear necessary Personal Protective Equipment (PPE) such as safety gloves, eyewear, etc., while setting up the machine. - Disconnect the machine from power source before attempting any kind of set-up adjustments to avoid electrical hazards. - Active presence of a trained firstresponder or safety officer on site during the machine operation hours. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
