Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Unsecured equipment, Lack of safety training	3H	<ul style="list-style-type: none"> - Implement a thorough safety training program that will educate workers about the potential hazards, safe operating procedures and emergency protocols. - Develop and enforce a strict policy on the use of Personal Protective Equipment (PPE) to defend against injuries. - Ensure all equipment is securely fixed onto a stable foundation base to prevent accidents due to slippage or toppling. - Review the layout of the workplace to eliminate unnecessary obstacles, providing clear pathways for workers. - Regularly inspect tools and equipment to detect and rectify any faults or damage promptly. - Provide appropriate signage to remind staff about the risks and safety precautions applicable to their task. - Invest in proper maintenance of machines by trained professionals to detect and fix faults that could lead to hazardous incidents. - Store heavy equipment at a low level to minimise risk of injury if equipment falls or shifts unexpectedly. - Create and enforce strict no-go zones around dangerous machinery where necessary. - Make sure the workplace has adequate lighting and ventilation to ensure workers' health and visibility while handling metal stamping tasks. - Install reliable safety features like emergency stop buttons on all machines. - Mandate regular breaks for workers to minimize fatigue-induced errors, leading to serious incidents. - Institute a two-man rule for certain high-risk tasks – no one should perform these tasks alone without someone nearby trained to assist in an emergency. 	2M
2. Machine Start-up	Unexpected start-ups, Electrical hazards	4A	<ul style="list-style-type: none"> - Ensure that all machine operators are properly trained on the Metal Stamping Press and have been given comprehensive safety briefings prior to operation. - Implement a lockout/tagout system to prevent unexpected start-ups. This entails de-energising the machine and putting a lock or tag on the power source so it can't be started up accidentally. - Regularly inspect and maintain electrical equipment and fixtures to prevent electrical hazards. - Always turn off the machine and disconnect from power before doing any inspection, maintenance, adjustments, or repairs. - Use appropriate personal protective equipment (PPE) such as safety goggles, gloves, and steel-toed shoes for added protection while operating the machine. - Keep the work area around the machine clean and clutter-free to minimise trip and fall hazards. - Ensure the machine is grounded correctly to avoid electrical faults or shocks. 	3H

			<ul style="list-style-type: none"> - Follow strict procedures for starting up the machine, with checks in place to ascertain that all safety devices function properly before operation commences. - Install emergency stop buttons at easily accessible locations around the machine. Train operators on when and how to use these. - Make certain operators only utilise tools & equipment approved for use with the Metal Stamping Press machine, as incompatible tools might cause unexpected reactions or damages. - Regularly update and review safe working practices and procedures associated with the machine startup to ensure they remain relevant and effective. 	
3. Loading Material	Falling objects, Trauma, Injury, Risks		<ul style="list-style-type: none"> - Workers must be appropriately trained on how to load materials onto the metal stamping press. This includes correct lifting and loading techniques. - Use of Personal Protective Equipment (PPE), such as safety glasses, gloves, and steel-toed shoes should be enforced during the loading process. - Workers should be familiarised with the emergency stop button or procedures to halt operation if needed. - Regular equipment maintenance and checks are crucial to reduce risk of sudden malfunctions that could cause falling objects or trauma injuries. - Adequate lighting should be provided to ensure workers can see clearly while loading materials onto the press. - A designated spotter or supervisor should be present to oversee work activities and ensure safety measures are being followed. - Encourage use of proper handling tools e.g. forklift, pallet jack, etc., which can minimise direct handling of heavy materials and hence lower risks of injury. - A clean and organised workplace will help prevent tripping hazards during material handling. - Implement a buddy system for loading heavy items – never allow a single worker to handle a heavy load alone. - Restrict access to only necessary personnel in the immediate area where the press is being loaded. - Storage racks and shelves for material storage should be sturdy and well anchored to prevent falls or accidental topples. - An updated Risk Assessment plan should be developed for loading tasks to identify potential risks and guide prevention measures. - Ensure workers take regular breaks to combat fatigue, which can lead to errors in judgement or clumsiness, thereby causing accidents. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
