Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Improper training, Lack of personal protective equipment	2M	<p>Here are eleven detailed control measures to be taken for the work step 'Preparation' when handling a metal wire bending machine:</p> <ul style="list-style-type: none"> <li>- Provide thorough training: Ensure all workers using the bending machine have received comprehensive, hands-on training on its correct operation and emergency procedures.</li> <li>- Workplace induction: Implement an orientation programme to familiarise new staff with workplace safety rules and procedures.</li> <li>- Regular workplace inspections: Make it a routine to conduct regular checks around the working area to ensure the environment is clean, safe and free from hazards.</li> <li>- Personal Protective Equipment (PPE): Mandate the use of appropriate PPE such as safety glasses, hearing protection and sturdy gloves.</li> <li>- Safety briefings: Conduct routine safety meetings to remind staff about potential risks associated with the use of a metal wire bending machine and how to mitigate them.</li> <li>- User manual highlights: Encourage workers to read and understand the machine's user manual thoroughly, including its specific risks and hazard mitigation strategies.</li> <li>- Maintenance: Regularly maintain the metal wire bending machine following the manufacturer's guidelines. 			<ul style="list-style-type: none"> <li>- Ensure the area around the machine is dry at all times to prevent electrical hazards.</li> <li>- Remove any metallic objects such as jewellery or watches that could conduct electricity.</li> <li>- Stay well clear of the machine after flipping the switch on, simply observe for accurate operation.</li> <li>- Ensure clear signage indicating the risk of electric shock is visibly posted around the work area.</li> <li>- Install adequate guarding systems such as barriers and safety screens to protect operators working with the machine.</li> <li>- Provide training to workers on emergency procedures, how to identify potential hazards and report them immediately.</li> <li>- Use lock-out and tag-out procedures when performing maintenance or repairs on the machine.</li> <li>- Have first aid measures and equipment readily available in case of an accident during the setup or use of the machine.</li> </ul>

Operating Machine	Hand injuries, Noise exposure	3H	<ul style="list-style-type: none"> <li>- Ensure all operators have undergone formal training specific to the Metal Wire Bending Machine to gain knowledge and understanding of its operation and potential risks.</li> <li>- Regularly inspect and maintain the machine to ensure it's working correctly and safely, following manufacturer's instructions.</li> <li>- Use proper safety gloves to protect hands from injuries during operations.</li> <li>- Avoid loose clothing, jewellery or other items that could potentially become caught in the machine and cause injury.</li> <li>- Make use of emergency stop buttons and interlocks, ensuring they are easily accessible during machine operation.</li> <li>- Implement a noise management plan, with sound barriers and sound absorbing materials where necessary to reduce noise exposure.</li> <li>- Rotate employees on regular intervals to minimise their individual exposure to noise.</li> <li>- Regular hearing checks for employees exposed to high level noise and provide ear protective devices such as earmuffs or earplugs.</li> <li>- Minimise physical interactions with the machine during an operation. Where possible, employ automated processes to transport the metal wires into the machine.</li> <li>- Clearly mark danger zones around the machine which indicate safe spaces from which to operate the machine.</li> <li>- In the event of a jam or malfunction, follow established lockout/tagout procedures before attempting to rectify the problem.</li> </ul>	2M

## SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

**The SWMS must be reviewed regularly** to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

**The SWMS must be monitored regularly** for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
