ALL PERSONNEL PARTICIPATING IN ANY ACTIVITY ON THIS SWMS MUST HAVE THE FOLLOWING COMMUNICATED

Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Preparation	Slippery surfaces, trip hazards from clutter	3H	<ul style="list-style-type: none"> - Conduct a site inspection prior to starting work to identify any existing slippery surfaces or potential trip hazards. - Ensure cleaning schedules are in place, with appropriate attention given to spills or wet floors to prevent slips. - Minimise clutter by organising tools and materials properly and designating specific areas for storage. - Display clear signage for any temporary wet or greasy areas to warn workers of potential slip hazards. - Implement slip mats or floor coverings in areas prone to wetness or high foot traffic. - Ensure sufficient lighting in all work areas to increase visibility and help spot potential hazards easily. - Regular inspection for damage or wear and repair promptly to prevent uneven surfaces that lead to trips. - Provide appropriate footwear with slip-resistant soles for workers, especially in environments known for slippery floors. - Educate workers on the importance of keeping walkways clear and reporting any hazards immediately. - Install handrails or grab rails in areas where extra support may be needed to prevent slips and falls. - Position cords and cables out of walkways and secure them to avoid creating trip hazards. - Use barriers or cordons for areas under maintenance or when floors are being treated with slippery substances. - Develop and enforce a housekeeping policy that prioritises maintaining a tidy and organised workspace at all times. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
