If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Designate a competent health and safety representative to conduct regular site safety checks and assessments, they would also ensure that all safety protocols are being adhered to. 	1L

Where possible, restrict access to the area while the Mobile Crusher is running. This minimises the risk of injury to bystanders or non-authorised staff.
