Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

**Notes on Hierarchy of Controls:** Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Incorrect manual handling, Inadequate training	2M	<ul style="list-style-type: none"> <li>- Conduct thorough risk assessment: In order to fully understand the risks, a hazard identification and risk assessment should be performed before commencement of any task.</li> <li>- Training and competency-based approach: All workers must be adequately trained on how to operate the mortar mixer safely. This includes understanding the manufacturer's instructions and safety procedures.</li> <li>- Correct manual handling: Workers should be educated on proper manual handling techniques to avoid strain and injury. This may include bending at the knees when lifting, using both hands, and not overreaching or twisting.</li> <li>- Utilise proper equipment: Workers should use appropriate personal protective equipment (PPE), like gloves, safety glasses, and dust masks, as well as the correct tools for handling materials.</li> <li>- Regular breaks: To prevent fatigue, which can lead to accidents, ensure that workers are given regular breaks.</li> <li>- Adequate supervision: There should always be a qualified supervisor overseeing work to ensure the correct safety procedures are being followed.</li> <li>- Limit access to operation area: Only those necessary for the mixing task should be allowed in the immediate vicinity of the mixer, to limit potential injuries from machine operation.</li> <li>- Safe equipment maintenance: Regular inspections and maintenance of the mortar mixer should be undertaken to ensure it's safe for use.</li> <li>- Emergency procedures: Workers should be familiarised with emergency stop procedures, first aid facilities and fire-fighting equipment in case of an incident.</li> <li>- Proper signage: Clear labels and signals next to the equipment and around the worksite to inform workers of potential hazards.</li> <li>- Policies against alcohol and drug use: These substances can impair motor control and judgement, increasing the risk of accidents. A strict policy against such usage should be enforced.</li> </ul>	1L
2. Material Transportation	Slips, trips and falls, Struck by moving objects	3H	<ul style="list-style-type: none"> <li>- Ensure the pathway for material transportation is clear and free from any obstruction or debris which may result in slips, trips, and falls.</li> <li>- Employees should be provided with suitable Personal Protection Equipment (PPE) such as safety boots which have a good grip to prevent slips and falls.</li> <li>- Implement a Safe Work Method Statement (SWMS), outlining all steps of the task, hazards associated with each step, and controls to manage risks.</li> <li>- Train workers on manual handling techniques to safely lift, carry, and transport heavy objects aiding in reducing injuries resulting from mishandling.</li> <li>- All loads should be evenly balanced and not overloaded to maintain the stability of the mortar mixer while it's on move; this reduces the risk of overturning causing injuries.</li> </ul>	2M

			<ul style="list-style-type: none"> <li>- Use mechanical aids where possible to transport or lift heavy materials; dollies, pallet jacks, or forklifts can be used to minimize physical strain.</li> <li>- Regularly inspect the working area to keep it clear from spills which could cause slip hazards.</li> <li>- Appropriate signage should be posted to make everyone aware of the transport pathways, minimizing the risks of being struck by moving objects.</li> <li>- Visibility clothing or High-Visibility PPE should be provided and worn by employees involved in material transportation. This ensures they are clearly seen by other workers, especially if operating machinery like forklifts.</li> <li>- Employ proper traffic management protocols within the work site to control movement of vehicles and equipment; this includes setting speed limits, designating pedestrian zones, and specifying areas for loading/unloading.</li> <li>- Adopt a buddy system for tasks that involve heavy lifting and those dealing with large, unwieldy items. Two persons working together can provide an extra layer of safety.</li> <li>- Implement regular rest breaks during transportation activities to reduce worker fatigue which could lead to accidents.</li> </ul>

Machine Set-Up	Contact with moving parts, Poor maintenance practices	3H	<ul style="list-style-type: none"> <li>- Regular Machine Inspection: Ensure timely and routine inspection of the mortar mixer to identify any signs of wear, damage or malfunction.</li> <li>- Training Programs: Provide comprehensive training to the workers handling the machine on safe operating procedures, hazard identification and risk control measures.</li> <li>- Protective Gears: Ensure all employees are adequately equipped with necessary personal protective equipment (PPE) such as gloves, safety glasses and proper footwear while operating the machine.</li> <li>- Clear Work Area: Maintain a clear work area around the machine to prevent accidental contact with moving parts.</li> <li>- Follow Manufacturer's Instructions: Operate the machinery strictly in accordance with manufacturer's instructions for set-up, use, and maintenance.</li> <li>- Lockout/Tag-out Procedures: Implement lock out/tag out procedures during maintenance or repair works to ensure the machine is not accidentally powered up.</li> <li>- Emergency Stop Procedures: Always have an emergency plan in place, including easy access to an emergency stop button, and train staff on how to react in case of an accident.</li> <li>- Regular Maintenance Schedule: Establish a regular maintenance schedule for the machine, based on manufacturer's recommendations, to detect and address potential issues early on.</li> <li>- Noise Control: Use noise control measures such as acoustic enclosures or earplugs if the machine operation is excessively noisy to guard against hearing damage.</li> <li>- Safety Checklist: Develop and adhere to a safety checklist before machine start-up every time to ensure that all components are in proper working order.</li> </ul>	2M

## SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

**The SWMS must be reviewed regularly** to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

**The SWMS must be monitored regularly** for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
