Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Mould allergy, Slips on wet surfaces	2M, 2M	<ul style="list-style-type: none"> - Conduct a risk assessment to identify the likelihood and severity of mould allergy reactions among workers prior to commencing work. - Require the use of personal protective equipment (PPE) such as gloves, masks, and goggles to minimise direct exposure to mould spores. - Implement engineering controls such as proper ventilation systems to reduce airborne mould particles in the work area. - Provide training sessions for workers on the symptoms of mould allergies and appropriate action plans if symptoms appear. - Use barriers to designate and cordon off areas where mould casting is taking place to prevent unauthorised personnel from entering. - Ensure that slip-resistant footwear is provided and worn at all times when working in areas prone to wet surfaces. - Regularly inspect and maintain work areas to keep walkways clear of water and other potential slip hazards. - Develop and reinforce a cleaning protocol to promptly address spills and wet surfaces, using absorbent materials where necessary. - Encourage a reporting culture so workers feel comfortable reporting any hazardous conditions, including potential slip risks, immediately. - Schedule regular health monitoring for employees involved in mould casting to catch any developing allergies early. 	1L, 1L

Cleaning	Mould and dust inhalation, Allergic reaction	2M, 3H	<ul style="list-style-type: none"> - Use personal protective equipment (PPE) such as N95 respirators or P2 dust masks to prevent inhalation of mould and dust particles. - Wear safety goggles to protect eyes from dust and mould spores during cleaning operations. - Implement a wet cleaning method where possible to minimise dust dispersal into the air. - Ensure proper ventilation in the work area to reduce the concentration of airborne contaminants, using exhaust fans if necessary. - Conduct regular air quality monitoring to ensure dust and mould levels remain within safe limits. - Use vacuum cleaners with HEPA filters instead of brooms to remove dust particles effectively without spreading them into the air. - Provide training for workers on the health risks associated with mould and dust exposure and instruct them on correct cleaning techniques and PPE use. - Identify individuals with known allergies or asthma and assign them to tasks with lower potential for exposure to allergens. 	1L, 2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review process should be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
