ALL PERSONNEL PARTICIPATING IN ANY ACTIVITY ON THIS SWMS MUST HAVE THE FOLLOWING COMMUNICATED

Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Poor lighting, tripping hazards	2M	<ul style="list-style-type: none"> - Conduct a thorough lighting assessment to ensure adequate illumination throughout the workspace, especially in areas where furniture will be moved. - Use portable work lights or headlamps if existing lighting is insufficient, ensuring that they do not create glare or additional shadows. - Clear all walkways and work areas of any clutter, cords, or debris that could pose tripping hazards before beginning the moving process. - Mark/fix any uneven surfaces or potential trip points such as low steps or changes in flooring level with bright coloured tape or signage. - Ensure that only trained personnel familiar with safe manual handling techniques are involved in the preparation process. - Provide suitable personal protective equipment such as gloves with good grip to prevent slipping while handling awkward-size items. - Plan the route ahead of time to identify any obstacles and ensure there is clear access from the starting position to the destination. - Limit distractions during the preparation phase by communicating effectively with other team members and ensuring mobile phones or other interruptions are minimized. - Verify that the floor surface in the moving path is dry and not slippery, taking necessary measures to control any wet areas immediately. - Implement a buddy system where two individuals perform checks on each other's setup to mitigate missed hazards or issues during preparation. 	1L

Pre-move Inspection	Incorrect lifting technique, furniture too heavy for personnel	3H	<ul style="list-style-type: none"> - Ensure all team members are trained in proper lifting techniques to prevent strain or injury. - Assess the weight and size of the furniture to determine the number of personnel required for safe handling. - Use mechanical aids such as dollies or trolleys to assist in moving particularly heavy or awkward items. - Conduct a risk assessment of the area to identify any obstructions or hazards that could impede safe movement. - Encourage team communication to coordinate movements and avoid sudden shifts or loss of balance. - Mark any sharp edges or protrusions on the furniture with visible tape to prevent cuts or bruises during handling. - Wear appropriate personal protective equipment, such as gloves and steel-toed boots, to protect against injury. - Break down larger pieces of furniture into manageable components if possible. - Determine clear, unobstructed pathways for the movement of furniture to the desired location. 	2M

Marking Pathways	Tripping over obstacles, slipping on wet surfaces	3H	<ul style="list-style-type: none"> - Conduct a thorough walkthrough of the area to identify and remove any obstacles or tripping hazards prior to the move. - Clearly mark the designated pathway with bright tape or cones to guide workers safely through. - Ensure all cables and cords are securely fastened or routed away from walking paths. - Maintain clear communication among all team members about the chosen pathway and any potential hazards. - Identify wet surfaces and place warning signs as well as absorbent mats to prevent slipping. - Limit foot traffic in the area during the furniture move to minimise distractions and potential collisions. - Provide adequate lighting along the pathway, especially in dim or enclosed spaces. - Instruct workers to wear appropriate footwear with non-slip soles to enhance grip and stability. - Regularly check weather conditions if moving furniture outdoors, and delay the move if inclement conditions pose additional risks. - Allocate responsibility to a safety spotter who can guide the team and alert them to developing hazards in real-time. - Ensure that all team members have undergone proper training for moving heavy and awkward items, including safe lifting techniques. 	1L

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
