If an incident or a near miss occurs, all work must sto, an atately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.			
Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.			
The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

2. Inspection of Pots	Tripping over pot, Cuts from sharp edges	2M	 Conduct a visual inspection of the work area to identify and remove any tripping hazards around large pots. Wear cut-resistant gloves to protect hands from sharp edges on pots. Use safety boots with a reinforced toe to prevent injuries from falling pots. Ensure all pots are placed on stable surfaces to minimise the risk of being knocked over. Utilise appropriate lifting techniques to avoid tripping while carrying or moving pots. Implement training sessions for workers on handling pots safely to increase awareness of potential hazards. Use wheeled platforms or trolleys designed for transporting heavy loads to move large pots safely. Keep pathways clear and well-lit to reduce the risk of tripping when inspecting pots. Regularly maintain pot edges and surfaces to eliminate or smoothen any sharp areas. Clearly mark areas where pots might be placed temporarily during inspections to alert workers. Assign a spotter to assist and guide workers during the movement and inspection of large pots. 	1L

SAFE WORK IN THE STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains a fective of must be reviewed (and revised if necessary) if relevant control measures are revised. The view process should be carried out in consultation with workers (including contractors of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU mast ensure that advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a rest of the review are advised of the changes in a way that will enable them to implement their duties and the involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.
