Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Site Assessment	Uneven ground, presence of obstacles	3H	- Conduct a visual inspection of the site to identify any potential hazards, such as debris or potholes, and clear them before commencing work. - Ensure adequate lighting is available if working in low-light conditions to spot uneven ground or obstacles better. - Use appropriate signage to alert others of the maintenance work being conducted on the site to prevent accidental interference. - Wear suitable personal protective equipment like safety boots and gloves to protect against slips, trips, or cuts. - Mark off the area where the mower blade change will be conducted with cones or barriers to prevent unauthorised access. - Utilise spotters or co-workers to assist in identifying potential hazards that may be difficult for the operator to see while working. - Perform a pre-task briefing with all personnel involved to discuss the identified hazards and agreed-upon control measures. - Choose a stable, level surface for conducting the mower blade change to prevent accidents due to instability. - Avoid working on saturated or muddy ground when possible to reduce the risk of slipping or sinking. - Regularly check weather conditions; postpone work during adverse weather to prevent unsafe working environments. - Designate a clear equipment storage area away from the immediate work zone to minimise tripping hazards. - Ensure tools and equipment required for the mower blade change are in good working order and are used correctly to avoid unnecessary strain or injury.	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review process should be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
