The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Keep stairways free of obstacles and clutter to prevent tripping and ensure a clear path for foot traffic. Implement a no-running policy on stairs to reduce the risk of slips, trips, and falls. Regularly inspect handrails for stability and repair any loose or damaged sections immediately. Use anti-slip coatings on stairs made of materials such as wood or metal that may become slippery when wet. Develop an incident reporting procedure to quickly address and rectify any hazards identified by workers using the stairs. 	2M

SAFE WORK IN THE STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains a fective of must be reviewed (and revised if necessary) if relevant control measures are revised. The view process should be carried out in consultation with workers (including contractors of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU mast ensure that advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a rest of the review are advised of the changes in a way that will enable them to implement their duties and the involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.
