ALL PERSONNEL PARTICIPATING IN ANY ACTIVITY ON THIS SWMS MUST HAVE THE FOLLOWING COMMUNICATED

Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Poor visibility, Unsuitable footwear	3H	<ul style="list-style-type: none"> - Conduct a pre-task assessment to identify any visibility issues and address them before proceeding. - Ensure the stairwell or escalator area is well-lit to improve visibility while carrying bulky items. - Wear appropriate, non-slip footwear with good treads to prevent slips or trips on stairs or escalators. - Use both hands to securely hold the item, maintaining a clear line of sight whenever possible. - If vision is obstructed by the item, seek assistance from a colleague to help guide you safely up or down. - Plan the route in advance to be aware of the number of steps and any potential hazards along the way. - Avoid carrying other objects that may further impede your vision or balance while negotiating stairs or escalators. - Ensure nothing does not create additional tripping hazards or restrict movement when carrying bulky items. - Utilise mechanical aids like stair climbing trolleys or ask for assistance if the item is too heavy or unwieldy. - Regularly inspect footwear for wear and replace as needed to maintain effective traction. - Implement a buddy system where one person carries the item and another assists by guiding and ensuring safe passage. 	2M
2. Moving items to stairs/escalator	Rough surfaces, Heavy objects	3H	<ul style="list-style-type: none"> - Conduct a risk assessment to identify potential hazards associated with the specific stairs or escalators before starting the move. - Use appropriate personal protective equipment (PPE) such as gloves and steel-capped boots to protect against injuries from rough surfaces and heavy objects. - Arrange for manual handling training for workers to ensure they understand safe lifting techniques and load-bearing capacities. - Utilise trolleys, hand trucks or similar moving aids to transport bulky items to the stairs/escalator wherever possible to minimise manual handling risks. - Ensure that the pathway to the stairs or escalator is clear of obstacles and well-lit to prevent trips and falls. - Have multiple persons involved in the process, allowing for team lifting practices to distribute the weight of heavy items safely. - Securely fasten all loose parts on bulky items to prevent shifting during movement, using straps or ropes if necessary. - Measure and check the dimensions of both the item and the stairway/escalator to confirm that the item can be maneuvered safely through the space. 	2M

Positioning the bulky item	Tripping, Falling objects	4A	<ul style="list-style-type: none"> - Ensure all team members involved are trained in manual handling techniques to minimise the risk of tripping. - Inspect the stairs or escalator for any obstacles, damage, or slippery surfaces before proceeding. - Use proper footwear with non-slip soles to reduce the likelihood of slipping or tripping. - Plan the route in advance and identify turning points if necessary to prevent overexertion. - Communicate clearly among team members regarding positioning and movements to ensure coordinated actions. - Utilise handrails when available to maintain balance and stability while carrying bulky items. - Assign spotters on both ends of the item to guide and secure the load, preventing falling objects. - When possible, use mechanical aids such as stair climbing trolleys or lifting devices to handle heavy or awkward items. - Securely wrap or tie the bulky item to prevent parts from detaching and posing a hazard. - Avoid overcrowding the stairs or escalator; allow sufficient space between team members to manoeuvre safely. - Conduct a test lift to assess the weight and balance of the bulky item before attempting full movement. - Keep the area clear of non-essential personnel to reduce distractions and prevent accidents. - Implement a communication system (e.g., signals, radios) to maintain safety if verbal communication is not possible. 	3H

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
