Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Handling heavy equipment, prolonged exposure to noise	3H	<ul style="list-style-type: none"> - Conduct manual handling training sessions for employees to reduce the risk of injuries when lifting heavy equipment. - Use mechanical lifting aids or trolleys to transport heavy equipment where possible to minimise manual handling. - Ensure all employees wear appropriate personal protective equipment (PPE) including hearing protection like earplugs or earmuffs. - Rotate employees through different tasks to limit prolonged exposure to noise for any single individual. - Schedule regular breaks for workers exposed to high noise levels to reduce the duration of continuous exposure. - Implement a noise monitoring programme to continuously assess noise levels and ensure they remain within safe limits. - Designate specific areas for equipment setup away from high-traffic or confined spaces to minimise noise impact and congestion. - Educate employees about the risks associated with prolonged noise exposure and the importance of using PPE consistently. - Inspect and maintain noise-producing equipment regularly to ensure it operates as quietly as possible. - Use sound barriers or absorbent materials around noisy equipment to decrease overall noise levels in work areas. - Develop and communicate an emergency response plan for managing sudden increases in noise levels or equipment mishandling. 	2M

Equipment set-up	Tripping over wires, continuous exposure to loud sound	3H	<ul style="list-style-type: none"> - Use cable covers or tape to secure wires, preventing tripping hazards. - Establish clearly marked walkways and work areas to minimise the risk of tripping over equipment. - Employ barriers or warning signs around testing equipment to alert workers to potential obstacles. - Implement a "cables off the ground" policy where possible to reduce tripping risks. - Provide hearing protection such as earmuffs or earplugs for all personnel within proximity of the noise source. - Schedule regular breaks for anyone exposed to loud sounds to prevent prolonged exposure. - Equip employees with personal noise dosimeters to monitor real-time exposure levels. - Ensure all personnel are trained in identifying and mitigating noise-related hazards. - Keep non-essential personnel out of high-noise areas during testing procedures. - Conduct pre-testing inspections to ensure all equipment, including cables and soundproofing materials, are in proper working condition and securely positioned. 	1L

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review process should be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
