Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Preparation	Slippery surfaces, Inadequate lighting	3H	- Conduct a thorough site inspection to identify all slippery surfaces and document them. - Use anti-slip mats or slip-resistant coatings on identified slippery surfaces. - Ensure that spill kits are readily accessible and personnel are trained on their use for immediate response to liquid spills. - Implement proper drainage systems to prevent pooling of water or other liquids. - Provide adequate signage to warn workers of slippery areas and ensure it's visible and legible. - Schedule regular housekeeping to maintain clean and dry floors, and assign responsibility to specific workers. - Ensure proper footwear with slip-resistant soles is worn by all workers on site. - Inspect and maintain existing lighting fixtures to ensure they are functioning correctly and replace any faulty ones promptly. - Install temporary portable lighting in areas with inadequate permanent lighting. - Conduct regular site inspections during different times of day to assess changing lighting conditions and address deficiencies. - Educate workers about the risks associated with inadequate lighting and slippery surfaces during toolbox talks and training sessions. - Place reflective tape or markers in poorly lit work zones to improve visibility. - Develop and communicate an emergency response plan specifically addressing incidents of slips or trips due to inadequate lighting or slippery surfaces.	2M
2. Equipment Setup	Faulty equipment, Electrical shock	4A	- Ensure all equipment is regularly inspected and maintained by qualified personnel to prevent faults. - Conduct a pre-start check on all equipment to ensure it is in proper working condition before use. - Use equipment only for its intended purpose to avoid overloading and potential failures. - Ensure that all electrical equipment is properly grounded and free from exposure to moisture. - Train all personnel thoroughly on the correct setup and operation of each piece of equipment. - Ensure that all equipment used complies with Australian safety standards and regulations. - Implement lockout/tagout procedures to ensure equipment is not accidentally started during maintenance or repair. - Establish and maintain a safe work perimeter around the equipment setup area to keep unauthorised personnel away. - Provide appropriate Personal Protective Equipment (PPE) such as insulated gloves and footwear to protect against electrical shock.	3H

			- Ensure all power sources and connections are securely installed and protected from physical damage. - Install Residual Current Devices (RCDs) on all applicable electrical circuits to quickly shut off power if a fault is detected. - Have emergency response and first aid plans in place, and ensure that all workers are familiar with them.

Material Handling	Manual handling strains, Sharp object injuries	3H	- Conduct a manual handling risk assessment to identify potential risks and implement appropriate control measures. - Provide training for workers on safe lifting techniques and proper material handling procedures. - Use mechanical aids such as trolleys, forklifts, or hoists to minimise the need for manual handling whenever possible. - Encourage team lifting for heavy or awkward loads where mechanical aids are not available or feasible. - Ensure all workers use appropriate personal protective equipment (PPE) such as gloves to reduce the risk of sharp object injuries. - Maintain a clean and organised work area to prevent trips and falls during material handling tasks. - Implement a "No lone working" policy for high-risk manual handling activities to ensure assistance is available if needed. - Clearly mark and store sharp or hazardous materials separately to avoid accidental contact during handling. - Rotate tasks among workers to limit prolonged exposure to repetitive motion and reduce strain. - Regularly inspect and maintain tools and equipment used for handling materials to ensure they are in safe working condition. - Limit the weight of manually handled loads to reduce strain and risk of injury to workers. - Reinforce early reporting of discomfort or injuries to address potential risks promptly and adjust work practices accordingly.	2M

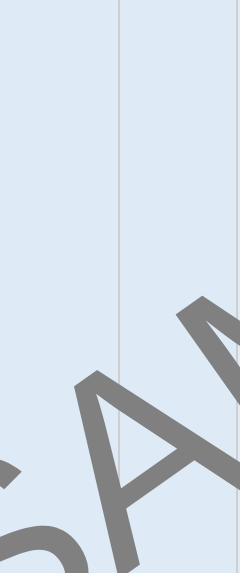

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review process should be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
