Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Exposure to sharp objects, Slips and trips	3H	<ul style="list-style-type: none"> - Conduct a pre-operation inspection of the work area to ensure it is free from obstructions and hazards such as loose objects or debris that may cause slips or trips. - Wear appropriate personal protective equipment including cut-resistant gloves, safety glasses, and steel-capped boots, to minimise the risk of injury from exposure to sharp objects. - Ensure the radial arm saw is securely anchored to prevent movement during operation which could result in accidental cuts or lacerations. - Verify that all guards are in place and functioning correctly before commencing any work with the saw. - Maintain a clean and organised work area to reduce the likelihood of stepping on tools or offcuts that could lead to slips or trips. - Use signage or barriers to alert others of the work area and potential hazards, preventing unauthorised personnel from entering the space. - Verify the cutting material is stable and securely positioned to avoid unexpected movement when cutting. - Ensure adequate lighting in the work area to enable clear visibility and reduce the risk of accidents involving sharp tools. - Keep hands and body parts away from the blade's path by using push sticks or other tools designed to guide material through the saw. - Confirm the emergency stop mechanism is clearly accessible and functional, allowing for quick response if an adverse event occurs. - Properly train all operators on the safe usage and maintenance of the radial arm saw, emphasising awareness around sharp components. - Regularly review and update safety procedures, drills, and hazard identification related to radial arm saw operations. - Encourage a culture of open communication among team members about hazards to foster an environment focused on proactive risk management. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
