Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Slips, trips and falls, Hand-arm vibration	3H	<ul style="list-style-type: none"> - Conduct a site walk-around to identify potential trip hazards such as uneven ground, debris, or other obstacles and ensure they are removed or marked. - Ensure all personnel wear appropriate PPE including slip-resistant footwear to minimise the risk of slips, trips, and falls. - Implement a housekeeping protocol ensuring that tools and equipment are stored safely away from walkways and work areas are kept tidy. - Provide adequate lighting for all areas where bulldozers will be operating to help workers see and avoid trip hazards. - Establish clear communication protocols for workers on foot around bulldozer operation zones to reduce collision risks. - Conduct pre-operational checks on bulldozers to ensure steps, handles, and cabin access are secure and in good condition to prevent falls when entering or exiting the machine. - Limit exposure time to vibrating machinery by rotating operators regularly, thus reducing the risk of hand-arm vibration syndrome. - Use machinery with vibration-damping features and ensure bulldozers are well-maintained to reduce excessive vibration. - Train operators on best practices for maintaining comfortable hand positions and minimising grip force while operating machinery to lessen the impact of vibrations. - Monitor workers' health regarding symptoms of hand-arm vibration syndrome and respond promptly to any signs of discomfort or injury. - Designate specific pathways and operational zones for bulldozers to follow, limiting their contact with pedestrian zones to manage safety effectively. - Provide training sessions for workers to understand the importance of hazard identification and proper use of personal protective gear to prevent workplace injuries. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
