Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Slips, trips and falls, electrical shock from faulty equipment	2M	<ul style="list-style-type: none"> - Conduct a worksite inspection prior to operation to identify and rectify potential slip, trip, and fall hazards such as wet floors or loose cables. - Ensure that electrical outlets are installed and maintained according to recognised standards to prevent exposure to faulty wiring. - Require all staff to wear non-slip footwear while in the coffee machine area to reduce the risk of slips and falls. - Regularly maintain and inspect the automated coffee machine to ensure all electrical components are functioning properly. - Install residual current devices (RCDs) on electrical circuits to quickly cut off electricity in case of a fault, preventing electrical shock. - Keep food clean and dry by immediately wiping any spills and using appropriate signage to warn of possible hazards. - Provide adequate lighting in the work area to help individuals clearly see any potential slip or trip hazards. - Implement standard operating procedures for checking and reporting any exposed wires or damaged power cords on equipment. - Use cable management solutions, such as cable covers or ties, to organise cables and prevent tripping hazards around the coffee machine. - Educate employees on proper bending and lifting techniques when handling coffee machine supplies to minimise the risk of trips and falls. - Implement routine staff training sessions focused on identifying and addressing workplace hazards related to the use of automated coffee machines. - Display emergency contact information and first aid resources conspicuously within the vicinity of the coffee machine. - Ensure all employees using the coffee machine are trained on its proper operation and aware of emergency shut-off procedures. - Place an easily accessible and regularly checked fire extinguisher near the coffee machine to address potential electrical fires. 	1L

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
