Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

2. Starting The Machine	Trapped fingers, Electrical faults	4A	<ul style="list-style-type: none"> - Conduct a pre-start checklist to verify that the machine is in good working condition. - Ensure that all operators have received proper training and are competent in using the meat slicer. - Use cut-resistant gloves when operating the machine to mitigate the risk of finger injuries. - Ensure that the power supply is within the recommended voltage and circuits are not overloaded. - Install emergency stop buttons on easily accessible parts of the machine for immediate shutdown if necessary. - Maintain a safe distance from moving parts by using designated hand tools provided with the slicer. - Post clear and visible safety signage around the machine to remind operators of potential hazards. - Implement a regular maintenance schedule to inspect wiring and connections for any signs of wear or damage. - Keep hands away from the blade area when starting the machine to prevent accidental contact. - Verify that all guards and safety devices are correctly positioned and functioning before starting the equipment. 	3H

Loading Meat	Cutting injuries, Repetitive strain injury	3H	<ul style="list-style-type: none"> - Ensure all operators are trained in the safe use of meat slicers and proper handling techniques. - Use cut-resistant gloves when handling and loading meat onto the slicer to minimise the risk of cutting injuries. - Ensure the slicer is turned off and unplugged before loading or adjusting the meat. - Position hands and fingers away from the blade at all times during the loading process. - Use the meat holder or pusher provided with the slicer to secure the meat instead of using hands. - Arrange workstation to allow for ergonomic access to the slicer, reducing repetitive strain. - Rotate tasks among employees to avoid prolonged exposure to repetitive movements. - Adjust the height and position of the meat slicer to suit the operator's comfort level, minimising awkward postures and motions. - Perform regular maintenance checks to ensure that the slicer's blade is sharp and functioning correctly, to reduce the force needed and prevent mishaps. - Install a non-slip mat or platform to provide stable footing while operating the slicer. - Implement a regular break schedule to allow operators time to rest and stretch. - Provide adequate lighting around the slicer to improve visibility and precision during operation. - Display clear signage near the slicer indicating safety precautions and emergency procedures. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
