Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Slips, trips and falls, Electrical hazards	2M	<ul style="list-style-type: none"> - Conduct a site inspection to identify any potential slip or trip hazards such as uneven surfaces, debris, or spills and ensure they are removed or marked clearly. - Ensure all work areas are well-lit to reduce the likelihood of trips and falls due to unseen obstacles. - Wear appropriate non-slip footwear to provide better grip and minimise the risk of slipping. - Keep all walkways and work areas tidy by regularly removing tools, cords, and other materials that could cause tripping. - Use ground fault circuit interrupters (GFCIs) on all electrical power supplies to prevent electrical shock hazards. - Inspect power tools and extension cords for damage before use, ensuring they are in good working condition with no exposed wires or defects. - Ensure that electrical equipment is rated for outdoor use if tasks are being conducted outside, preventing moisture-related hazards. - Avoid overloading electrical circuits by knowing the power requirements of tools and not using more than one high-draw electrical tool on the same outlet. - Clearly label and secure all live electrical parts and components to protect against accidental contact. - Regularly test all safety switches in accordance with manufacturer instructions and Australian standards to ensure they function correctly. - Implement proper housekeeping procedures, including securing cables above head height or taping them down, to prevent entanglements and trips. - Provide training for all workers in the correct operation and handling of power tools to reduce the chance of operational errors leading to injury. - Designate specific storage areas for all tools and equipment when not in use to avoid clutter and potential tripping hazards. - Establish an efficient communication protocol for alerting team members about any identified hazards to maintain overall site safety awareness. 	1L

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
