Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Tripping over onsite debris, Unsafe work environment	2M	<ul style="list-style-type: none"> - Conduct a site inspection to identify potential tripping hazards such as debris, uneven surfaces, or cluttered pathways. - Clearly mark walkways and work areas with signage to inform workers and visitors about designated paths and potential hazards. - Remove unnecessary debris and obstructions before skip bin delivery and placement to ensure a clear working area. - Use barriers or cones around the skip bin area to prevent unauthorised access and alert workers of potential hazards. - Provide adequate lighting for all work areas, especially in low-light conditions, to improve visibility and reduce the risk of tripping. - Ensure stable and even ground for the safe placement of the skip bin to prevent tilting or movement that could cause toppling. - Train workers on hazard identification and encourage reporting of any unsafe conditions they observe during operations. - Regularly inspect and maintain equipment used in conjunction with skip bins to ensure it is in good condition and free from defects. - Establish communication protocols for informing workers of potential tripping hazards identified after the initial inspection. - Provide personal protective equipment such as sturdy footwear with non-slip soles to all personnel working near skip bins. - Display contact information for site health and safety officers prominently around the skip bin area for quick reporting of hazards. - Implement housekeeping protocols to keep work areas organised and ensure tools and materials are stored properly. - Schedule regular safety meetings to reinforce the importance of maintaining a tidy and safe working environment around skip bins. 	1L

			<ul style="list-style-type: none"> - Perform regular inspections of the ground conditions around the skip bin area, ensuring it remains level and stable. - Use gravel or temporary ground stabilisation matting in areas where surface conditions could lead to slipping during wet weather. - Provide personal protective equipment such as gloves with good grip and slip-resistant footwear to reduce the risk of slipping. - Install adequate lighting for outdoor areas to ensure high visibility and reduce the chance of tripping on uneven ground. - Establish clear communication lines among workers to coordinate movements when carrying items to the skip bin. - Clearly mark uneven surfaces and edges to warn personnel of potential slip hazards. - Rotate tasks among workers to limit prolonged or repetitive movements that can lead to strain injuries, especially for tasks involving heavy lifting. - Position skip bins as close as possible to the waste source to reduce the distance workers have to carry heavy items.

Transporting the Bin	Collision with other vehicles or pedestrians, Falling objects during transportation	4A	<ul style="list-style-type: none"> - Ensure the vehicle transporting the skip bin is regularly maintained and roadworthy to prevent malfunctions during transit. - Train drivers on defensive driving techniques and safe loading practices to minimise the risk of collisions. - Use visibility aids such as reflective tape and flags on both the vehicle and skip bin for better awareness by other road users. - Secure all items within the skip bin with appropriate tarpaulins or nets to prevent objects from falling out during transportation. - Conduct thorough checks to ensure the bin is properly attached to the transport vehicle before departure. - Implement a traffic management plan that designates specific routes to avoid high pedestrian areas and peak traffic times. - Install and utilise functioning GPS tracking and communication systems for constant monitoring and support in case of emergencies. - Brief all personnel involved in the transport operation about the potential hazards and appropriate emergency response procedures. - Use spotters when vehicles are reversing or manoeuvring in bounded spaces to provide assistance and monitor surroundings for safety. - Display clear warning signs and signals on the transport vehicle, indicating the presence of an oversize or overweight load. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
