ALL PERSONNEL PARTICIPATING IN ANY ACTIVITY ON THIS SWMS MUST HAVE THE FOLLOWING COMMUNICATED

Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Disposal of waste	Biological hazards, Sharp objects	3H	<ul style="list-style-type: none"> - Provide employees with appropriate personal protective equipment (PPE), including gloves and protective clothing, to protect against potential biological hazards and sharp objects. - Implement proper waste segregation procedures to ensure that sharp objects are separated from other types of waste. - Use designated containers for the disposal of sharp objects and label them clearly to prevent accidental contact or puncture. - Educate employees on the recognition and handling of biological hazards present in waste materials. - Ensure regular and thorough handwashing facilities are available and encourage their use after handling waste materials. - Display clear signage around waste disposal areas notifying workers of potential hazards and required PPE. - Conduct regular safety training sessions focused on the safe handling and disposal of waste, highlighting specific risks linked to biological hazards and sharp objects. - Establish clear communication channels for reporting and responding to any incidents involving exposure to biological hazards or injuries from sharp objects. - Schedule frequent inspections and audits of waste disposal procedures to identify and rectify potential hazards promptly. - Arrange for routine health surveillance for workers regularly exposed to significant biological hazards as a proactive measure. 	2M

Documentation	Eye strain	2M	<ul style="list-style-type: none"> - Provide adjustable desk chairs and computer monitors to allow workers to set up their workspace ergonomically, reducing the risk of eye strain. - Ensure that computer screens are positioned at an appropriate distance from the eyes, typically about an arm's length away, to minimise strain. - Encourage regular breaks using the 20-20-20 rule: every 20 minutes, look at something 20 feet away for at least 20 seconds, helping to reduce eye fatigue. - Install anti-glare filters on computer screens to lessen the impact of glare and bright light, which can contribute to eye strain. - Implement adequate lighting in work areas, ensuring it is neither too dim nor too harsh, to aid in minimizing eye stress. - Educate employees on the importance of blinking regularly when working at a screen to prevent dry eyes, which are often a precursor to eye strain. - Promote the use of artificial tears or lubricating eye drops if employees experience dryness or irritation, after consulting with an optometrist. 	1L

Equipment maintenance	Electrocution, Burns		<ul style="list-style-type: none"> - Conduct regular inspections on electrical equipment to ensure it is in good working order and comply with Australian standards. - Ensure all personnel receive relevant training and are competent in using and maintaining the electrical equipment safely. - Use lockout/tagout procedures during maintenance to ensure equipment is de-energised before work begins. - Implement a permit-to-work system for maintenance tasks involving high-risk equipment or situations. - Provide appropriate personal protective equipment (PPE) such as insulated gloves and flame-resistant clothing to reduce risk of electrocution and burns. - Install and maintain safety signage to warn of electrical hazards and required PPE. - Ensure tools and testing equipment are regularly tested, maintained, and rated for the level of voltage encountered during maintenance tasks. - Establish clear communication protocols to coordinate maintenance activities and ensure everyone is aware of ongoing tasks. - Ensure emergency shut-off switches are clearly labelled and accessible in case of accidental contact with live components. - Develop an emergency response plan that includes first aid measures for electrical shock and burn injuries. - Regularly audit and review workplace health and safety procedures relating to equipment maintenance to incorporate improvements and address any deficiencies. - Ensure there is adequate lighting and ventilation in maintenance areas to provide safe working conditions. - Designate a qualified supervisor to oversee maintenance activities and ensure compliance with all safety measures and regulations. 	3H

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
