If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Use counterfeit detection tools or UV light scanners for all cash transactions to detect fraudulent currency. Adopt strict verification processes for non-cash payments, such as checking identification and matching signatures for credit card transactions. Display visible signage indicating limited cash on premises after hours to dissuade potential robberies. 

SAFE WORK IN THE STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains a fective of must be reviewed (and revised if necessary) if relevant control measures are revised. The view process should be carried out in consultation with workers (including contractors of the SWMS and their health and safety representatives who represented that work group at the workplace.
