Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Isolate Machine	Failure to properly isolate, Unexpected start-up	4A	<ul style="list-style-type: none"> - Develop and implement an isolation procedure that includes clear steps for safely turning off the machine. - Ensure all employees are trained in isolation procedures and understand the importance of proper isolation. - Use lockout/tagout (LOTO) devices to physically secure isolation points, making it impossible to re-energise the machine without removing the locks or tags. - Verify electrical disconnection using a calibrated voltage tester before beginning any work on the equipment. - Display visible warning signs indicating that the machine is isolated and work is being performed. - Assign a competent person to oversee the isolation process, ensuring that all steps are correctly followed. - Implement a checklist system to ensure each step of the isolation process is completed before work begins. 	2M

Verification of Isolation	Inadequate verification, Electric shock	3H	<ul style="list-style-type: none"> - Conduct a pre-start briefing to emphasise the importance of proper isolation verification, ensuring all team members understand the process. - Use a lockout/tagout (LOTO) system where each team member applies their own lock and tag to the isolation point. - Confirm isolation by using an appropriate electrical testing device to verify zero energy state before commencing work. - Ensure testing device is calibrated and functioning correctly by testing it on a known live circuit prior to use. - Assign a competent and authorised person to oversee the verification process and ensure compliance with procedures. - Display clear and visible signage at the isolation points to inform others that work is being carried out and equipment must not be energised. - Implement a buddy system where a second individual double-checks the isolation verification performed by the primary worker. - Keep a detailed log of the isolation process, including the time and personnel involved in both applying and verifying the isolation measures. - Conduct periodic training sessions for workers on the latest safety standards and verification techniques for various types of machines and electrical systems. - Establish an emergency communication procedure to quickly address any issues or failures in the isolation process, ensuring rapid response to potential electric shock incidents. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
