Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

			<ul style="list-style-type: none"> - Provide comprehensive training sessions for workers handling pin welding machines regarding the proper use, inspection, and maintenance of their safety equipment to limit the risk of injury. - Implement a system that requires workers to sign on the functionality and adequacy of their safety equipment before commencing any work with the pin welding machine. - Appoint a dedicated Health and Safety Officer who will hold responsibility for monitoring the adherence of employees to outlined health and safety protocols, as well as the ongoing availability and functionality of all sites' protective gear. - Encourage open communication channels for employees to report damaged or inadequate safety equipment without fear of retribution, promoting a proactive approach to hazard reduction. - Update or purchase industry-standard protective gear in line with advances in technologies designed to enhance workplace safety, ensuring that staff remain protected using the most effective tools and resources. - Conduct periodic audits of PPE storage facilities, ensuring that the equipment is stored correctly to preserve its quality and effectiveness, whilst also guaranteeing ease of access for staff when required. - Carry out thorough investigations into any workplace incidents involving defective protective gear, determining the cause and implementing changes needed to prevent future occurrences. This could include reinforcing training, revising procedures, or improving equipment quality standards.

Replace or repair any damaged parts immediately. - Inspect the welding machine's grounding system and ensure that it is functioning correctly by following the manufacturer's recommendations or checking with a qualified electrician. - Always turn off the power supply before connecting or disconnecting the pin welding machine to minimise the risk of electrical shock. - Use machines rated for industrial use in the workplace environment, ensuring they meet the required Australian Standards for electrical safety and performance. - Provide training for operators on proper connection procedures, electrical safety protocols, and hazard identification. This training should be updated every time a new machine is introduced or when there are changes to existing equipment. - Establish a regular maintenance schedule for the pin welding machine, including inspections of electrical circuits, moving components, and earthing connections. Keep a maintenance log for tracking and record keeping. - Perform regular risk assessments to identify any potential hazards of the pin welding machine or its power connection, implementing improvements where necessary. - Clearly label any electrical equipment, switches, and outlets associated with the pin welding machine to help avoid accidental disconnections or electrical shocks during operation. - Ensure that workers wear appropriate personal protective equipment (PPE) while working with the pin welding machine, such as insulated gloves, voltage-rated shoes, and eye protection. - Post warning signs about the dangers of improper power connections and electrical shocks around the workplace to remind workers of the potential hazards. 	1L

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
