Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

**Notes on Hierarchy of Controls:** Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

			<ul style="list-style-type: none"> <li>- Keep work area clean and well-lit: A well-organised workspace allows inspectors to efficiently locate and inspect components without accidentally bumping into other tools or tripping on clutter - this helps to avoid equipment damage and accidents.</li> <li>- Follow manufacturer's guidelines and recommendations: Always consult and adhere to the manufacturer's instructions for proper inspection, maintenance, and operation procedures to ensure optimal performance and longevity of the planer.</li> <li>- Train employees on proper equipment inspection procedures: Regularly conduct training sessions for workers to teach them correct methods for inspecting and maintaining the planer, thus reducing the risk of overlooked hazards or improper handling.</li> <li>- Use only compatible components: Replace damaged components or accessory parts with genuine, manufacturer-approved replacements to maintain safe and efficient operation of the planer.</li> <li>- Monitor noise levels: If possible, monitor the noise level emitted by the planer during operations. Excessive or unusual noises may indicate internal damage or the need for maintenance.</li> <li>- Report and address issues promptly: Encourage employees to report any issue, hazard, or malfunction found during equipment inspection. Immediately attend to these concerns to minimise risks and keep operations running smoothly.</li> </ul>	
3. Workspace Setup	Poor lighting, Inadequate ventilation	2M	<ul style="list-style-type: none"> <li>- Provide adequate workspace lighting: Ensure that the area designated for using the Planer has sufficient illumination to clearly see the equipment, tasks at hand, and any potential hazards in the area.</li> <li>- Install portable lighting if necessary: If fixed lighting is insufficient or not available, consider using portable task lighting to help illuminate the work area adequately.</li> <li>- Conduct regular checks on workspace lighting levels: Periodically assess the brightness around the workspace, especially when ambient light changes due to weather conditions or time of day, and adjust lighting parameters accordingly.</li> <li>- Keep windows clear and blinds open for natural light: Allow as much natural light into the workspace as possible by cleaning windows regularly and adjusting blinds to let sunlight in.</li> <li>- Ensure proper ventilation: Make sure that the workspace is well-ventilated, either through natural means (open windows, doors) or mechanical means (humidity-control systems, HVAC), to eliminate dust buildup and maintain a safe working environment.</li> <li>- Use respiratory protection equipment: Workers should wear appropriate dust masks or respirators to minimise the inhalation of harmful particles produced during the planing process.</li> <li>- Conduct regular air quality assessments: Establish a schedule for frequently monitoring air quality within the workspace to ensure that air particles remain at acceptable levels.</li> <li>- Install dust extraction systems: Consider having a dust collection system installed to help capture and remove dust, while keeping the workspace clean and reducing exposure risk.</li> <li>- Implement regular housekeeping procedures: Schedule routine cleaning and maintenance of the work area to reduce dust and other debris accumulation.</li> <li>- Train workers on safe operating practices: Educate employees about potential hazards associated with poor lighting and inadequate ventilation, and how to follow control measures to mitigate those risks effectively.</li> </ul>	1L

## SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

**The SWMS must be reviewed regularly** to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

**The SWMS must be monitored regularly** for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
