Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Preparation	Overexertion, Slips/Trips/Falls, Sunburn	2M	<ul style="list-style-type: none"> - Conduct a pre-start meeting to review the work plan and discuss safety protocols with all workers involved in planting shrubs. - Ensure that all workers are trained in proper lifting techniques to prevent overexertion and provide mechanical aids for heavier tasks. - Wear appropriate footwear with non-slip soles to minimise the risk of slips, trips, and falls on uneven or wet surfaces. - Implement a working schedule for breaks, allowing workers to rest from physical exertion to reduce fatigue and the risk of overexertion. - Set up temporary barriers or signs to clearly mark hazardous areas, such as uneven terrain or recently irrigated sections, to alert workers. - Use shade structures or rotate workers into shaded areas whenever possible to protect against sunburn and heat-related illnesses. - Require the use of broad-spectrum sunscreen with high SPF ratings and reapplication every two hours when working outdoors under direct sunlight. - Encourage wearing wide-brimmed hats, long-sleeved clothing, and UV-rated sunglasses to further limit exposure during the preparation phase. - Designate a specific path for transporting plants and tools to prevent tripping hazards and maintain clear walkways at all times. - Equip all workers with personal protective equipment, including gloves and kneepads, to safeguard against scrapes and strains while preparing the site. 	1L

Site Analysis	Allergic Reaction to Plants/Shrubs, Misjudgment of Area	2M	<ul style="list-style-type: none"> - Conduct an assessment of workers for any known allergies to specific plants or shrubs before starting. - Provide training on identifying common allergenic plants and shrubs in the work area. - Ensure workers have and use appropriate personal protective equipment such as gloves, long sleeves, and masks to minimise skin contact and inhalation of allergens. - Have an emergency response plan in place, including access to first aid and allergy medication if necessary. - Clearly mark and identify areas where allergenic plants may exist to inform all personnel working on site. - Schedule planting activities during cooler parts of the day to reduce environmental stress and potential allergic reactions. - Implement a clear communication plan so that any worker experiencing an allergic reaction can immediately get support from colleagues and supervisors. - Use non-allergenic plant species wherever possible to avoid triggering allergies among workers. 	1L

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
