ALL PERSONNEL PARTICIPATING IN ANY ACTIVITY ON THIS SWMS MUST HAVE THE FOLLOWING COMMUNICATED

Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	High noise exposure, equipment malfunction	2M	<ul style="list-style-type: none"> - Conduct a noise level assessment to determine the volume and frequency of sound produced by each instrument. - Provide training for musicians on the risks of noise exposure and the importance of hearing protection. - Schedule regular breaks during practice or performances to reduce continuous noise exposure. - Implement administrative controls such as rotating musicians to limit individual exposure time. - Use acoustic shields or barriers between musicians to help reduce noise levels. - Opt for quieter instruments or configurations where possible, such as using electronic drum kits with headphones. - Enforce maximum volume limits during rehearsals and performances. - Encourage musicians to use custom-fitted earplugs designed for music to protect against harmful noise levels while maintaining sound quality. - Ensure equipment is regularly maintained and serviced to prevent malfunctions that may increase noise. - Keep musician areas organised to minimise the risk of tripping or accidents while moving instruments or equipment. - Use noise-cancelling technology where applicable to assist in reducing surrounding noise interference. - Position amplifiers and speakers strategically to disperse sound more evenly and reduce concentrated noise exposure. - Incorporate sound-absorbing materials within rehearsal spaces to reduce overall noise levels. - Establish a protocol for immediate reporting and addressing of any equipment malfunction to prevent unexpected increases in noise levels. 	1L

Practice Session	Hearing loss from continuous sound, repetitive strain injuries	3H	<ul style="list-style-type: none"> - Use noise-reducing earplugs or earmuffs specifically designed for musicians to reduce sound exposure. - Implement regular breaks during practice sessions to minimise continuous sound exposure and reduce the risk of hearing damage. - Conduct initial and periodic audiometric testing to monitor hearing levels and detect any early signs of hearing loss. - Position amplifiers and loudspeakers away from direct ear level to control the volume of sound reaching the ears. - Limit practice session durations and ensure they are within recommended safe noise exposure limits. - Engage in hand and wrist stretching exercises before, during, and after practice to prevent repetitive strain injuries. - Use ergonomic stands and supports that promote proper posture to minimise physical discomfort and strain while playing. - Adjust instrument straps and seating to avoid awkward positions and repetitive movements that could contribute to strains. - Schedule a warm-up routine incorporating gentle scales and exercises to prepare muscles and joints prior to intensive play. - Encourage musicians to learn and use correct techniques for their specific instruments to reduce physical stress and overuse. - Maintain equipment regularly, ensuring that instruments and their components operate smoothly to lessen unnecessary force requirements. - Educate musicians about the risks associated with prolonged exposure to loud music and improper technique to foster proactive health management. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
