Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Set Up Safety Barriers | Fall hazards, Inadequate barrier placement | 3H | <ul style="list-style-type: none">- Conduct a site assessment to identify potential fall hazards before setting up barriers.- Ensure all safety barriers are high-visibility and compliant with Australian Standards.- Position barriers at least 1.5 meters away from the edge of any fall hazard area.- Use weighted bases or secured fittings to prevent barriers from being easily moved or knocked over.- Provide additional signage alerting workers and visitors to the presence of fall hazards in the vicinity.- Implement exclusion zones where barriers are not feasible using hazard tape and warning signs.- Train all staff on the importance of barrier placement and the specifics of the setup locations.- Regularly inspect barriers throughout the duration of work to ensure they remain secure and effective.- Install guard rails around elevated work platforms and edges where workers might be exposed to falls.- Use designated entry and exit points for workers to prevent dismantling or moving barriers accidentally.- Assign a site supervisor to monitor barrier integrity and ensure compliance with SWMS protocols.- Ensure communication devices are available for all workers to report any issues related to barrier placement and maintenance immediately.

Check Weather Conditions | High winds, Rain | 3H | <ul style="list-style-type: none">- Monitor weather forecasts and conditions closely before starting work.- Establish a safe working limit for wind speeds and rain intensity.- If high winds or rain are forecasted, postpone outdoor activities until conditions improve.- If work must proceed in light rain or moderate winds, ensure workers wear appropriate PPE like waterproof gear and high-visibility clothing.- Avoid working near trees or structures that could become unstable in high winds.- Have a clear evacuation route established in case of severe weather.- Communicate weather status and safety instructions to all workers and visitors.- Stop work immediately if conditions worsen beyond the safe working limits.- Document weather-related incidents or near-misses for future reference.- Review and update the SWMS based on actual weather experiences.- Provide training on weather awareness and emergency procedures to all staff.- Ensure first aid kits and emergency contact numbers are readily accessible.- Consider alternative indoor tasks during adverse weather periods.- Reassess risk levels as weather conditions SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.
