If an incident or a near miss occurs, all work must sto, anately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.			
Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.			
The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

2. Arrival at Location	Traffic Accidents, Collision with pedestrians	2M	 Conduct a pre-arrival briefing to discuss traffic management and pedestrian safety with the team. Plan the arrival time to avoid peak traffic periods for minimal delay and congestion. Designate a spotter to guide the vehicle and communicate with the driver via hand signals or radio. Use high-visibility signage at the entrance and around the area to warn incoming vehicles and pedestrians. Ensure all workers wear high-vis clothing and PPE for increased visibility while working near traffic. Establish a safe entry and exit point for vehicles to prevent potential collisions. Implement speed restrictions and set up temporary barriers to control vehicle flow in the work area. Position flaggers if necessary to manage traffic, ensuring they stand in safe locations. Implement an utine object for any loose or corroded components on the trailer, such as bolts, welds, at fitting, and pair any defects before use. Uting structuresistant surfaces or mats around the trailer workspace to minimise the chance of slipping, specially, wet conditions. Usablish a protocol for regular communication among team members to address any immediate hazards or concerns that arise during the inspection. Use chocks or wedges under the trailer wheels to prevent unexpected movement while conducting an inspection. Display adequate signage and barriers around the area to warn others not involved in the task to keep a safe distance, thereby minimising the risk of accidents. 	2M

SAFE WORK IN THE STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains a fective of must be reviewed (and revised if necessary) if relevant control measures are revised. The view process should be carried out in consultation with workers (including contractors of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU mast ensure that advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a rest of the review are advised of the changes in a way that will enable them to implement their duties and the involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel.
