Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

**Notes on Hierarchy of Controls:** Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Improper handling, Damaged equipment	2M	<ul style="list-style-type: none"> <li>- Ensure proper training and qualification of workers handling cordless power tools, with an emphasis on safety procedures and correct handling techniques.</li> <li>- Conduct regular tool box talks to provide relevant safety information and updates relating to cordless power tool usage.</li> <li>- Inspect equipment for visible defects, damage, and wear and-tear before use. Damaged equipment must be flagged and removed from service until repaired or replaced.</li> <li>- Implement a maintenance programme to regularly service and maintain cordless power tools according to the manufacturer's guidelines.</li> <li>- Select the appropriate type and size of tool for the specific job, in compliance with manufacturer recommendations.</li> <li>- Hold power tools by insulated gripping surfaces whenever possible during operation to minimise the risks associated with inadvertent contact with other surfaces or objects.</li> <li>- Always wear Personal Protective Equipment (PPE), including gloves, safety boots, ear protection, and eye protection when using cordless power tools.</li> <li>- Store power tools securely when not in use, away from water as well as excessive heat or cold conditions.</li> <li>- Maintain a tidy working environment around cordless power tools, with adequate space for maneuvering and safeguarding against inadvertent contact with other individuals or machinery.</li> <li>- Ensure that any battery-powered cordless tools are charged and stored in the proper manner, with batteries disconnected when not in use.</li> <li>- Keep cords, cords adapters, and connectors away from sharp edges, oil, or grease, to prevent damage and reduced functionality.</li> <li>- Establish cordless power tool handling zones within the worksite, complete with designated "No Go" areas where unauthorised personnel are prohibited.</li> <li>- Designate a specific individual responsible for monitoring the use of cordless power tools on-site to ensure adherence to safety protocols.</li> <li>- Enforce strict adherence to work breaks for those operating cordless power tools to avoid potential fatigue-related accidents.</li> </ul>	1L

			<ul style="list-style-type: none"> <li>- Encourage workers to report any suspicious defects and malfunctions immediately to supervisors, promoting a proactive approach towards maintaining excellent equipment quality and preventing accidents.</li> <li>- Providing regular training sessions to educate employees on hazard identification and prevention, as well as safe work practices when using cordless power tools.</li> <li>- Securing all necessary personal protective equipment (PPE), such as goggles, gloves, hearing protection, and appropriate footwear, and enforcing its use during operations involving power tools.</li> <li>- Implementing an isolation and lockout/tagout system when necessary for faulty equipment, ensuring it cannot be used until repaired or replaced.</li> <li>- Proper storage of tools in designated areas, with secured covers or cases if applicable, protecting them from exposure to moisture and other environmental factors that may cause deterioration or electrical hazards.</li> <li>- Ensuring all cordless power tools and batteries are compliant with Australian safety standards and following manufacturers' guidelines for usage and maintenance.</li> <li>- Establishing a rigorous protocol outlining steps to be taken in the event of an accident or near-miss, providing comprehensive support to involved parties and facilitating continuous improvement in workplace health and safety.</li> <li>- Reviewing and updating the Safe Work Method Statement (SWMS) regularly, addressing identified risks and improvements in practice to ensure effectiveness and adherence to relevant legislation, industry codes, and Australian Standards.</li> </ul>	
3. Charging batteries	Overcharging, Battery leakage	2M	<ul style="list-style-type: none"> <li>- Use manufacturer-approved chargers: Ensure that all battery chargers are sourced from the original equipment manufacturer and comply with their recommended specifications to prevent overcharging.</li> <li>- Monitor charging duration: Keep track of the time taken for each charging cycle, and always adhere to the manufacturer's recommended charging time to prevent overcharging.</li> <li>- Inspect batteries: Regularly check each battery for any signs of damage, wear or swelling. If found, replace the faulty battery immediately to minimise the risks of leakage and overcharging.</li> <li>- Implement ventilation: Ensure proper ventilation in the charging area to dissipate any chemicals released from leaking batteries and to prevent overheating during charging.</li> <li>- Training and awareness: Provide education and training for all employees regarding the hazards associated with battery charging, including how to identify damaged batteries and report overcharging incidents.</li> <li>- Battery storage: Store batteries in a designated cool and dry location away from direct sunlight, heat sources, and combustible materials. This will reduce the risk of leakage and related hazards.</li> <li>- Charging stations: Set up dedicated and clearly marked charging zones with appropriate electrical installations and safety signage to ensure safe charging practices.</li> <li>- Emergency procedures: Develop and implement emergency response procedures to deal with incidents such as overcharging or battery leaks, ensuring all relevant personnel understand their roles in case of an emergency.</li> </ul>	1L

**SAFE WORK METHOD STATEMENT MONITORING AND REVIEW**

**The SWMS must be reviewed regularly** to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

**The SWMS must be monitored regularly** for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
