### ALL PERSONNEL PARTICIPATING IN ANY ACTIVITY ON THIS SWMS MUST HAVE THE FOLLOWING COMMUNICATED

Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

**Notes on Hierarchy of Controls:** Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Improper handling of pressure washer, Electrical hazards	2M	<ul style="list-style-type: none"> <li>- Make sure that all employees are properly trained on the use of a pressure washer before they begin work. This includes both operational training and safety protocols.</li> <li>- Regularly inspect the pressure washer for any signs of wear or damage. If found, ensure that these are repaired or replaced before the device is used again.</li> <li>- Ensure proper usage of personal protective equipment (PPE) including safety glasses, gloves and waterproof boots when working with the pressure washer.</li> <li>- Keep the pressure washer and electrical cables away from water sources to lower the risk of electric shock.</li> <li>- Only use a pressure washer in well-ventilated areas to prevent buildup of emissions from combustion engines.</li> <li>- Proper handling measures should be followed while transporting the pressure washers to and from the work site to avoid accidental tipping or spilling.</li> <li>- The work area should be clear of unnecessary objects or equipment that could potentially cause an injury or accident if sprayed.</li> <li>- Always keep a safety zone around the operating pressure washer to protect bystanders, animals, and other workers.</li> <li>- Encourage regular breaks during the operation of a pressure washer in order to reduce user fatigue and the chances of mishandling the equipment due to tiredness.</li> <li>- Maintain strict compliance with guidelines set out by the Workplace Health and Safety licensing authority for your region.</li> </ul>	1L
2. Equipment Setup	Tripping over cords or hoses, Noise pollution	3H	<ul style="list-style-type: none"> <li>- Ensure all equipment is in good working order before starting the task. Regular inspections and maintenance will allow early detection of potential defects that may cause accidents.</li> <li>- Lay out and secure hoses and cords in a manner that reduces the likelihood of tripping hazards. Use brightly coloured markers or safety flags to increase visibility.</li> <li>- Designate a specific clear area for equipment setup where movement is limited and chances of tripping can be minimised.</li> <li>- Use cord covers or other dedicated solutions to keep cords and hoses organised and free from tangling.</li> <li>- Employ noise reduction techniques like having machines with low decibel output or using sound barriers to minimise the noise pollution.</li> <li>- Ascertain that employees wear appropriate safety gear including earmuffs or earplugs to protect against noise pollution.</li> <li>- Train staff on correct methods of setting up the equipment and the importance of health and safety compliance.</li> </ul>	2M

			<ul style="list-style-type: none"> <li>- Constant cleanup of workplace to remove any accidentally accumulated clutter, which might lead to tripping.</li> <li>- Ensure staff take regular breaks to minimise fatigue which can contribute to accidents.</li> <li>- Have an Accident Prevention Plan at hand and make sure all workers are aware of it.</li> <li>- Require all workers to wear suitable and securely fastened footwear which has slip-resistant soles to help prevent slipping or stumbling.</li> <li>- Conduct safety briefings regularly to remind staff of potential hazards and safe practices while using pressure washers.</li> <li>- Limit inappropriate behaviour such as horseplay or misuse of equipment since this greatly escalates the risk of incidents.</li> <li>- Install emergency stop devices that can quickly deactivate the pressure washer if a hazardous situation arises.</li> </ul>	
3. Cleaning Process	High-pressure water, Chemical exposure	4A	<ul style="list-style-type: none"> <li>- Ensure all personnel are adequately trained on operating the pressure washer and handling chemical substances.</li> <li>- Implement a safe system of work for using high-pressure water that includes barricading off the work area to prevent unauthorised access.</li> <li>- Workers should wear appropriate Personal Protective Equipment (PPE) which could include waterproof footwear, safety glasses, gloves, earplugs, and waterproof clothing to protect against potential chemical splashes.</li> <li>- Adjust the pressure setting on the pressure washer to the minimum required level to successfully complete the task.</li> <li>- Avoid working from heights wherever possible; if unavoidable, ensure proper fall protection measures are in place.</li> <li>- Always hold the washer nozzle firmly with both hands to manage the back-force generated by the pressurised water.</li> <li>- Adequately ventilate the workspace as some cleaning chemicals may produce harmful vapours.</li> <li>- Employees must properly store and handle chemicals in accordance with their Safety Data Sheet and any other relevant instructions.</li> <li>- Regular equipment maintenance checks are necessary to ensure the high-pressure hose, connections and safety devices are working correctly.</li> <li>- Employ a spotter system when working near utility lines or potentially hazardous areas who can alert the operator of any impending danger.</li> <li>- Workers should stand stable on firm ground while operating the pressure washer to prevent slips and falls.</li> <li>- Develop an emergency plan inclusive of first aid procedures in the event that an incident does occur.</li> <li>- Ensure that all waste products, particularly hazardous chemicals, are disposed of responsibly following local regulations.</li> </ul>	2M

## SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

**The SWMS must be reviewed regularly** to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

**The SWMS must be monitored regularly** for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
