### ALL PERSONNEL PARTICIPATING IN ANY ACTIVITY ON THIS SWMS MUST HAVE THE FOLLOWING COMMUNICATED

Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

PPE (Personal Protective Equipment) is the least effective method.

Bus Inspection	Contact with moving parts, Hazardous fumes	3H	<ul style="list-style-type: none"> <li>- Conduct a pre-start safety briefing to ensure all personnel are aware of the potential hazards and control measures.</li> <li>- Ensure all personnel wear appropriate personal protective equipment (PPE), including gloves, safety glasses, and high-visibility clothing, to protect against contact with moving parts and exposure to fumes.</li> <li>- Turn off the bus engine and remove keys from the ignition before commencing inspection to eliminate the risk of contact with moving parts.</li> <li>- Use lockout/tagout procedures to ensure the bus cannot be started accidentally during inspection.</li> <li>- Establish exclusion zones around the inspection area to prevent unauthorised personnel from entering the hazardous area.</li> <li>- Provide adequate ventilation in the inspection area to disperse any hazardous fumes effectively.</li> <li>- Use portable exhaust extraction fans or systems if the inspection is to be conducted indoors or in a confined space.</li> <li>- Equip inspection personnel with gas detection devices to monitor the presence of hazardous fumes that may not be visible or immediately noticeable.</li> <li>- Keep a fire extinguisher rated for chemical fires nearby in case of ignition of fumes or other flammable materials.</li> <li>- Regularly inspect PPE for damage and replace it as necessary to ensure maximum protection for all workers involved in the inspection process.</li> </ul>	2M

Breakdown Location Identification	Working in remote areas, Poor weather conditions	3H	<ul style="list-style-type: none"> <li>- Conduct a thorough risk assessment specific to the breakdown location prior to dispatching recovery personnel.</li> <li>- Ensure all communication devices are fully charged and operational to maintain contact with base and emergency services if required.</li> <li>- Provide GPS devices or maps to drivers to assist in precise location identification in remote areas.</li> <li>- Implement a check-in system where workers regularly update their status and location with the home office.</li> <li>- Train personnel in navigation skills and using technological aids for accurate location detection, especially in poorly marked areas.</li> <li>- Equip vehicles and staff with weather-appropriate gear such as raincoats, thermal blankets, and high-visibility clothing.</li> <li>- Use reliable weather monitoring tools and apps to stay updated on current and forecasted conditions.</li> <li>- Schedule recovery operations during daylight hours when visibility is better wherever feasible.</li> <li>- Equip recovery teams with emergency kits including first aid, food, and water supplies in case of extended operations.</li> <li>- Ensure workers have adequate training on working safely in adverse weather conditions, including heat, cold, and wet environments.</li> <li>- Develop and communicate an emergency response plan that includes steps to manage potential isolation or delayed assistance due to remote locations.</li> <li>- Liaise with local authorities or landowners where applicable to obtain information on any known hazards or access issues related to specific breakdown sites.</li> <li>- Regularly maintain and inspect recovery vehicles and equipment to ensure reliability and safety during operations, minimizing the risk of additional breakdowns.</li> </ul>	2M

## SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

**The SWMS must be reviewed regularly** to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

**The SWMS must be monitored regularly** for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
