Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Fuel spillage, Fire or explosion	3H	<ul style="list-style-type: none"> - Ensure all personnel involved in the refuelling process are trained and aware of emergency procedures related to fuel spillage and fire. - Use only approved containers and equipment specifically designed for diesel or petrol, ensuring they are in good condition and leak-proof. - Check weather conditions before refuelling. Avoid refuelling during harsh weather conditions such as lightning storms or strong winds to minimize risk. - Clearly mark the designated refuelling area with appropriate safety signage to inform personnel and prevent unauthorized access. - Ensure spill kits are readily available at the refuelling site to contain and clean up any fuel spills promptly. - Maintain a minimum safe distance from potential sources of ignition, such as hot surfaces, open flames, or electrical equipment during the refuelling process. - Implement strict no-smoking policies within and around the refuelling area to prevent accidental ignition from cigarettes. - Ground the bus and refuelling equipment properly to dissipate static electricity that could ignite spilled fuel. - Regularly inspect hoses, seals, and fittings for signs of wear and tear or damage and replace them when necessary to prevent leaks. - Establish communication protocols involving two-way radios or hand signals to ensure clear communication between individuals involved in evacuating quickly in case of emergencies. - Schedule regular safety audits and inspections to continually assess the effectiveness of control measures and make improvements where needed. 	2M

Checking bus condition	Shock or electrocution, Mechanical injury	3H	<ul style="list-style-type: none"> - Ensure all staff are trained in electrical safety and aware of potential shock risks. - Use lockout devices on electrical systems before commencing checks to prevent accidental energization. - Conduct visual inspections for any exposed wires or signs of wear and tear before proceeding with the condition check. - Equip workers with appropriate personal protective equipment (PPE) such as insulated gloves and shoes to reduce risk of electrocution. - Implement a strict no-water or liquid rule near electrical components during bus inspections. - Ensure proper grounding of all electrical equipment prior to commencing work to reduce potential shock hazards. - Use tools with non-conductive handles when checking electrical components. 	1L

Bus engine started	Vehicle movement, noise exposure	2M	<ul style="list-style-type: none"> - Position the bus on a flat, stable surface away from high pedestrian traffic areas to minimize the risk of unintended vehicle movement. - Apply the parking brake securely and verify its effectiveness before starting the engine. - Use wheel chocks or ramps if parked on a slight incline to prevent any accidental rolling. - Ensure that all fueling equipment is safely stowed and not obstructing the driver's view or path of operation. - Conduct visual and auditory check around the bus to ensure no obstructions or individuals are in close proximity before starting the engine. - Implement a 'no-idle' policy in enclosed spaces to minimize exposure to exhaust fumes and related health risks. - Utilize hearing protection where necessary, especially when noise levels exceed safe exposure limits due to engine operation. - Communicate clearly with team members using hand signals or radios to coordinate movements and tasks around the bus environment. - Maintain a clear zone around the bus where only authorized personnel are allowed during the starting and refueling process. - Display appropriate signage indicating the bus is being fueled and the engine will be started, warning nearby workers and pedestrians. - Inspect and maintain engine components regularly to ensure optimal performance and reduce excess noise emissions. 	1L

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
